- SECTION 1. Chapter 291, Hawaii Revised Statutes, is 1 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 "§291- Costs. Beginning July 1, 2012, all costs 5 associated with the statewide parking program for persons with 6 disabilities shall be appropriated from the accessible parking 7 special account established under section 348F-A." 8 SECTION 2. Chapter 348F, Hawaii Revised Statutes, is 9 amended by adding a new section to be appropriately designated 10 and to read as follows: 11 "§348F-A Accessible parking special account. (a) The 12 disability and communication access board shall establish and 13 administer an accessible parking special account within the 14 disability and communication access board special fund 15 established under section 348F-7.
