#### A BILL FOR AN ACT

RELATING TO THE LONG-TERM AGRICULTURAL LEASE TASK FORCE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that small farmers and 2 locally-based agricultural enterprises are essential partners in 3 achieving the State's goal of increased food sustainability in 4 the State. Small farmers and agricultural enterprises face many 5 challenges, including limitations on lease terms that affect 6 their ability to pursue innovative solutions in the field of diversified agriculture. The legislature finds that providing 7 support to the State's small farmers and agricultural 8 9 enterprises serves the interest of the State in achieving food

10 sustainability.

11 SECTION 2. (a) There shall be established within the 12 department of agriculture for administrative purposes a long-13 term agricultural lease task force. The task force shall 14 develop a plan and make recommendations to expand the 15 availability of long-term leases favorable to small farms and 16 agricultural enterprises in order to improve community 17 investments in long-term food sustainability in the State.

3	Members of the task force shall serve without compensation		
4	but shall be reimbursed for travel expenses incurred in		
5	traveling from one island to another in the performance of their		
6	official duties.		
7	(e) The task force shall select from among its members a		
8	chairperson and any other officers it deems necessary.		
9	(f) The task force shall submit a report to the		
10	legislature documenting its progress, reporting its allowable		
11	travel expenses, and making recommendations for legislation to.		
12	address the issue of food sustainability no later than twenty		
13	days prior to the convening of the regular session of 2012.		
14	SECTION 3. There is appropriated out of the general		
15	revenues of the State of Hawaii the sum of \$ or so		
16	much thereof as may be necessary for fiscal year 2011-2012 to		
17	support the purpose and objectives of the long-term agricultural		
18	lease task force including:		
19	(1) Convening and operating the task force, including		
20	travel expenses for members who travel from one island		
21	to another to attend meetings; and		
22	(2) Preparing the report submitted to the legislature.
