# A BILL FOR AN ACT

RELATING TO SMALL BOAT HARBORS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 200-9, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"§200-9 Purpose and use of state small boat harbors.
4	(a) State small boat harbors are constructed, maintained,
5	and operated for the purposes of:
6	(1) Recreational boating activities;
7	(2) Landing of fish; and
8	(3) Commercial vessel activities.
9	[For the purpose of this section, "recreational boating
10	activities" means the utilization of watercraft for sports,
11	hobbies, or pleasure, and "commercial vessel activities" means
12	the utilization of vessels for activities or services provided
13	on a fee basis.] To implement these purposes, only vessels in
14	good material and operating condition that are regularly
15	navigated beyond the confines of the small boat harbor, and
16	which are used for recreational activities, the landing of fish,
17	or commercial vessel activities shall be permitted to moor,



1 anchor, or berth at [such] a state small boat harbor or use any 2 of its facilities.

3 (b) Vessels used for purposes of recreational boating 4 activities which are also the principal habitation of the owners 5 shall occupy no more than one hundred twenty-nine berths at Ala 6 Wai boat harbor and thirty-five berths at Keehi boat harbor, 7 which is equal to fifteen per cent of the respective total moorage space that was available as of July 1, 1976, at the Ala 8 9 Wai and Keehi boat harbors. Notwithstanding the purposes of 10 small boat harbors, moorage for commercial vessels and commercial vessel activities is not permitted in the Ala Wai and 11 12 Keehi boat harbors; provided that commercial catamarans, for which valid permits or registration certificates have been 13 14 issued by the department which allow the catamarans to operate 15 upon Waikiki shore waters for hire, may be permitted to moor in 16 Ala Wai boat harbor at facilities leased for commercial 17 purposes. The department shall allow a sole proprietor of a 18 catamaran operating with a valid commercial registration 19 certificate issued by the department for a commercial catamaran 20 to land its commercial catamaran on Waikiki beach and to operate 21 upon Waikiki shore waters for hire, to transfer the ownership of 22 the vessel from personal ownership to corporate or other

1 business ownership without terminating the right to operate 2 under the commercial registration certificate. The existing 3 commercial registration certificate shall be reissued in a 4 timely manner in the name of the transferee corporation or other 5 business entity. No commercial registration issued to an owner 6 of a commercial catamaran operating in the Waikiki area shall be denied or revoked without a prior hearing held in accordance 7 8 with chapter 91.

9 (c) Notwithstanding any limitations on commercial permits 10 for Maui county small boat facilities, vessels engaging in 11 inter-island ferry service within Maui county shall be afforded 12 preferential consideration for ferry landings, including the 13 issuance of a commercial operating permit and the waiver of any 14 applicable fees, at Maui county small boat facilities; provided 15 that:

16 (1) The vessel operator has been issued a certificate of
17 public convenience and necessity for the purpose of
18 engaging in inter-island ferry service that includes a
19 route within Maui county;
20 (2) The design and performance characteristics of the

3	(3)	The vessel operations will not result in unreasonable
4		interference with the use of Maui county small boat

6	(4)	All preferential consideration and waivers, including
7		any commercial permits issued under this section,
8		shall cease upon the vessel operator's termination of
9		inter-island ferry service within Maui county.
10	(d)	The chairperson may adopt rules pursuant to chapter 91
11	to furthe	r implement this section.
12	(e)	For purposes of this section:
13	"Com	mercial vessel activities" means the use of vessels for
14	activitie	s or services provided on a fee basis.
15	"Rec:	reational boating activities" means the use of
16	watercraft	t for sports, hobbies, or pleasure.
17	"Reg	ularly navigated" means, for a vessel, moved under the
18	vessel's d	own power from its assigned mooring within a small boat
19	harbor to	beyond the confines of the small boat harbor and
20	entrance of	channel at least once every six months. Vessels moored
21	in an off:	shore mooring area shall exit the confines of the
