BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 571, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 Jane and john doe filings; domestic abuse. (a) "§571-5 A court, upon petition by an alleged victim, after finding 6 significant and compelling circumstances that would make public 7 inspection inconsistent with the purpose of this section, shall make confidential from the public all subsequent documents or 8 9 portions of documents that would identify the alleged victim or 10 contain sufficient information from which the alleged victim's 11 identity could be discerned or inferred; shall allow a petition, 12 complaint, motion, or other papers to be filed identifying the 13 alleged victim as "jane doe" or "john doe" in cases of alleged 14 domestic abuse where the alleged victim has already received an 15 order of protection, temporary restraining order, or protective 16 order against the accused party to the petition or complaint 17 pursuant to section 586-3, 586-4, or 586-5.5, respectively; 18 provided that the court finds the "jane doe" or "john doe" HB944 HD1 HMS 2011-1973

4	(b) In considering a petition requesting a "jane doe" or
