
SECTION 1. Section 302A-251, Hawaii Revised Statutes, is

Instructional Days; Multi-Track Public Schools

Description:

Requires multi track public schools to meet the greater of one hundred seventy-one days or ninety per cent of the minimum number of days required of other non-charter public schools for each respective school year. Requires the Department of Education to submit to the legislature a plan to implement a school year for multi-track schools beginning with the 2015-2016 school year of no less than ninety per cent of the minimum number of instructional days required of other public schools. (HB945 HD1)
