A BILL FOR AN ACT

RELATING TO SCIENCE AND TECHNOLOGY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that innovation is an essential driver of economic growth and future competitiveness. 2 A thriving innovation economy promotes economic growth, fosters 3 new technologies, creates jobs, and keeps the United States 4 leading the global marketplace. States across the nation and 5 6 the Obama administration have committed to renewing the country's focus on innovation as a means of fostering economic 7 growth and creating high-wage jobs throughout the nation. 8 In Hawaii, the president of the University of Hawaii system 9 recently unveiled recommendations of a draft report authored by 10 the Advisory Council on Hawaii Innovation and Technology 11 Advancement on how the University of Hawaii can build private 12 sector high-wage jobs and partnerships. Report recommendations 13 included identifying research as an industry in Hawaii; 14

15 establishing the Hawaii Innovation Technology Exchange Institute

16 (HiTEx); encouraging collaboration by integrating

17 entrepreneurship into the university's curriculum; and

agriculture, data analytics, and Asian-Pacific health as key
areas for capitalizing on commercialization opportunities for
Hawaii.

4 In addition, in 2010, the senate committee on economic 5 development and technology and the house committee on economic 6 revitalization, business, and military affairs convened an informal small business discussion group to address the most 7 8 critical issues facing the small business sectors within Hawaii's economy. Representatives from the Chamber of Commerce 9 of Hawaii, construction and trades industries, community 10 nonprofits, the agricultural sector, food and restaurant 11 industries, retailing, the science and technology sector, the 12 commercial transportation industry, and interested stakeholders 13 developed a package of bills that address the most pressing 14 15 problems facing Hawaii's small business community.

16 The purpose of this Act is to support the findings of the 17 small business working group and the recommendations proposed by 18 the Advisory Council on Hawaii Innovation and Technology 19 Advancement regarding regulatory requirements faced by 20 businesses engaged in biotechnology research, by establishing a 21 task force to:

5	SECTION 2. (a) There is established a biotechnology task
6	force within the University of Hawaii for administrative
7	purposes only. The task force shall assess barriers faced by
8	businesses engaged in biotechnology research or other
9	activities, and develop recommendations and any legislation
10	required to expedite permit processing for the specialized needs
11	of biotechnology businesses, including importation of organisms
12	or other items that are typically classified as invasive species
13	or hazardous in some manner.
14	(b) The task force shall consist of representatives from
15	the:
16	(1) University of Hawaii system, including the college of
17	tropical agriculture and human resources, John A.
18	Burns school of medicine, and department of
19	oceanography;
