WHEREAS, the Agribusiness Development Corporation was 1 established by the Legislature in 1994 to facilitate the 2 transition of Hawaii's agriculture industry from the closure of 3 4 the sugar and pineapple plantations to a diversity of crops; and 5 6 WHEREAS, the Agribusiness Development Corporation is administratively attached to the Department of Agriculture to 7 bridge the void between public and private sector to address 8 complex agricultural issues; and 9 10 WHEREAS, the mission of the Agribusiness Development 11 12 Corporation is to partner with farmers, ranchers, and aquaculture groups to acquire and manage high-value lands, water 13 systems and infrastructure for commercial agricultural use, and 14 to direct research into areas that will lead to the development 15 of new crops, markets, and lower production costs; and 16 17 18 WHEREAS, since the inception of the Agribusiness Development Corporation, Hawaii's agriculture industry has 19 20 evolved tremendously and new agribusiness operations and other industries have recently been established on former plantation 21 22 lands; and 23 WHEREAS, the Agribusiness Development Corporation has the 24 ability to streamline the process of government to address 25 critical bottlenecks in various agricultural projects; and 26 27 WHEREAS, there is a need to review and assess the 28 performance of the Agribusiness Development Corporation and 29 whether it is meeting the present and future needs of the 30
