HOUSE RESOLUTION

RECOGNIZING AND COMMENDING CECILIO AND KAPONO ON THEIR LIFETIME ACHIEVEMENT AWARD AS CONTEMPORARY HAWAIIAN MUSIC ARTISTS.

1 WHEREAS, music has always played an integral role in Hawaiian culture, from traditional chants to the resurgence of 2 3 Hawaiian-influenced mainstream music in the late 20th century; 4 and 5 6 WHEREAS, the musical traditions celebrated in Hawaii 7 experienced a resurgence in the 1970s known as the Hawaiian 8 Renaissance; and 9 10 WHEREAS, introduced by mutual friends during the Hawaiian Renaissance, Cecilio Rodriquez and Henry Kapono Ka'aihue merged 11 into one, forming CECILIO & KAPONO, also known as "C&K", and 12 played their first gig at JJ's Café in 1973; and 13 14 15 WHEREAS, CECILIO & KAPONO's perfect blending of arrangements became known as the "C&K sound" that electrified 16 fans and ultimately led to eight consecutive months of sold-out 17 18 shows at Waikiki's Rainbow Villa which resulted in a multi-album recording contract with Columbia Records; and 19 20 WHEREAS, for nearly four decades, CECILIO & KAPONO have 21 captured many hearts around the world, releasing 14 albums and 22 23 producing numerous hit songs resulting in various Na Hoku Hanohano Awards, including Contemporary Album of the Year, Group 24 25 of the Year, Song of the Year, and Album of the Year; and 26 WHEREAS, classic CECILIO & KAPONO songs such as "About 27 You", "Highway in the Sun", "Lifetime Party", "Friends", "Good 28 Times Together", and "Sailin'" remain beloved island favorites; 29 30 and

1 WHEREAS, CECILIO & KAPONO have toured the nation and the 2 world, performing at sold-out concerts in Japan, Guam, Saipan, 3 Diego Garcia, Tahiti, and the Cook Islands, sharing the stage 4 with some of the greatest American artists of their time, 5 including Santana, Loggins & Messina, Boz Scaggs, Peter 6 Frampton, Cheech & Chong, and numerous others; and 7

8 WHEREAS, CECILIO & KAPONO and their highly-lauded work 9 continue to serve as a source of inspiration for contemporary 10 Hawaiian music and musicians, and remind us of all that is 11 remarkable about our island home; now, therefore, 12

13 BE IT RESOLVED by the House of Representatives of the Twenty-sixth Legislature of the State of Hawaii, Regular Session 14 15 of 2011, that this body hereby commemorates the Lifetime 16 Achievement Award of CECILIO & KAPONO, honors their contributions to contemporary Hawaiian music, expresses its 17 18 heartfelt thanks for the gift of music they have given to fans 19 worldwide and to the people of Hawaii, and extends to them its warmest aloha and best wishes for continued success in all 20 future endeavors. 21
