## HOUSE RESOLUTION

REQUESTING THAT ALL EATING ESTABLISHMENTS AT THE UNIVERSITY OF HAWAII-MANOA CAMPUS BE REQUIRED TO ACCEPT STUDENT MEAL CARDS.

WHEREAS, student meal plans provide a flexible, affordable, 1 and convenient method of dining at college campuses; and 2 3 WHEREAS, the University of Hawaii-Manoa has a variety of 4 meal plan options that can be used at resident dining locations 5 and at retail dining locations on campus; and 6 7 WHEREAS, students residing in the residence halls of the 8 University of Hawaii-Manoa are required to purchase a meal plan 9 each semester, while apartment residents and off-campus students 10 have the option to participate; and 11 12 WHEREAS, students at the Manoa campus use their school-13 issued identification cards as meal cards, which must be 14 presented at each meal; and 15 16 WHEREAS, the convenience of meal plans is diminished when 17 not every eating establishment at the Manoa campus accepts 18 student meal cards; and 19 20 WHEREAS, the Manoa campus comprises a multitude of 21 facilities stretched over a large land area; and 22 23 WHEREAS, students participating in a meal plan may be 24 inconvenienced by having to purchase meals at eating 25 establishments that are located far from their classes; and 26 27 WHEREAS, students may be discouraged from using university 28 facilities, such as libraries or study areas, that are not 29 located near eating establishments that accept meal cards; and 30 31 WHEREAS, promoting the convenience of meal plans for 32 participants is particularly important for students who live in 33

the residence halls and are required to participate in a meal 1 plan; and 2 3 WHEREAS, full participation in University of Hawaii-Manoa 4 5 meal plans by all on-campus eating establishments would maximize the value of the plans by making them more convenient for 6 student participants to use; now, therefore, 7 8 9 BE IT RESOLVED by the House of Representatives of the Twenty-sixth Legislature of the State of Hawaii, Regular Session 10 of 2011, that the University of Hawaii is requested to require 11 all eating establishments at the Manoa campus to accept meal 12 cards under the University's meal plans; and 13 14 BE IT FURTHER RESOLVED that certified copies of this 15 Resolution be transmitted to the President of the University of 16 Hawaii System, the Chancellor of the University of Hawaii-Manoa, 17 18 and the President of the Associated Students of the University of Hawaii-Manoa. 19 20 21 22 OFFERED BY
