## A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

If any provision of this Act, or the 6 application thereof to any person or circumstances is held 7 invalid, the invalidity does not affect other provisions or 8 applications of the Act which can be given effect without the 9 invalid provision or application, and to this end the provisions 10 of this Act are severable.
