## A BILL FOR AN ACT

RELATING TO AGRICULTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Good agricultural practices are guidelines 1 2 designed by the United States Food and Drug Administration and 3 Department of Agriculture to produce safe products and eliminate potential for product contamination. Good agricultural 4 practices, among other things, include guidance on human 5 hygiene, animals and their manures, water quality for irrigation 6 7 and produce rinse, and agricultural pesticides. These standards are being adopted by the world's leading farmers, who understand 8 that they have a responsibility to provide the safest food 9

10 possible to consumers.

Recently the Food Safety Modernization Act was signed into and law. The law authorizes the Food and Drug Administration and the Secretary of Human Services to increase inspections of many domestic food facilities and enhance detection of food borne illnesses.

16 Safe production, distribution, and consumer handling of 17 food requires knowledge of food borne pathogens, chemical 18 toxins, food quality, and labeling. Our current system of SB1142 SD2 LRB 11-2470.doc

1	regulation is understaffed, and the remaining staff are
2	unprepared or untrained for the rapid changes that have occurred
3	in risk assessment, changes in production and distribution
4	methodologies, and new foods and emerging pathogens. Food
5	safety programs are also not integrated among government
6	agencies, hampering communication and cooperation.
7	In addition, many of Hawaii's growers are not implementing
8	good agricultural practices. This failure to follow science-
9	based, risk-adverse food production practices is worsened by the
10	existence of the rat lungworm nematode in Hawaii. When
11	consumed, this nematode can cause serious illness, as has
12	happened numerous times during the past couple years.
13	The purpose of this Act is to:
14	(1) Establish a food safety and security program within
15	the department of agriculture; and
,16	(2) Make an appropriation to the department of agriculture
17	for the food safety and security program.
18	SECTION 2. Chapter 141, Hawaii Revised Statutes, is
19	amended by adding a new part to be appropriately designated and
20	to read as follows:
21	"PART . FOOD SAFETY AND SECURITY PROGRAM
22	§141- Food safety and security program; establishment.

Perform all inspections and certifications of 3 (2) agricultural commodities in an efficient, effective, 4 and expeditious manner; and 5 Develop and implement programs to educate and develop 6 (3) the agricultural industry to meet state and federal 7 laws, rules, and regulations. 8 9 For purposes of this section, "agricultural commodities" means any grain, livestock, poultry, fruit, plant, timber, or 10 any other item produced from agricultural activities and shall 11 include trees, shrubs, herbs, and other plants." 12 13 SECTION 3. Section 141-2, Hawaii Revised Statutes, is amended to read as follows: 14 "§141-2 Rules. Subject to chapter 91, the department of 15 agriculture shall adopt, amend, and repeal rules not 16 17 inconsistent with law, for and concerning: The introduction, transportation, and propagation of 18 (1)trees, shrubs, herbs, and other plants; 19 The quarantine, inspection, fumigation, disinfection, 20 (2) 21 destruction, or exclusion, either upon introduction 22 into the State, or at any time or place within the SB1142 SD2 LRB 11-2470.doc
