### A BILL FOR AN ACT

RELATING TO AGRICULTURE.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Supporting Hawaii agriculture assists hard-2 working local farmers and helps preserve agricultural jobs. Ιt 3 is estimated that eighty-five per cent of the State's consumer 4 goods are imported. Raising the level of Hawaii's food self-5 sufficiency increases the State's food security by protecting 6 against transportation disruptions. Buying local also keeps 7 money flowing through the State, directly and indirectly 8 supporting the State's residents.

9 Established as a Hawaii nonprofit corporation in 2009, 4 Ag 10 Hawaii is a collaborative private-public sector partnership 11 focused on sustainable agricultural economic developments. The 12 partnership is committed to raising the awareness of the 13 importance of agriculture and expanding the agricultural 14 industry in Hawaii. The 4 Ag Hawaii partnership instituted the 15 "Buy Local, It Matters" slogan campaign, which aims to encourage 16 residents to support Hawaii farmers by making conscious 17 decisions to purchase locally produced agricultural products.

3	Hawaii's agriculture, which will serve a public purpose by
4	helping the State move towards improved food security.
5	SECTION 2. There is appropriated out of the general
6	revenues of the State of Hawaii the sum of \$500,000 or so much
7	thereof as may be necessary for fiscal year 2011-2012 as a grant
8	pursuant to chapter 42F, Hawaii Revised Statutes, to the 4 Ag
9	Hawaii nonprofit corporation to enhance the "Buy Local, It
10	Matters" campaign through:
11	(1) Expanded print, television, and radio media exposure;
12	and
13	(2) Participation with the Hawaii tourism authority,
14	Hawaii visitors and convention bureau, Hawaii
15	Restaurant Association, and necessary county private
16	and public agricultural organizations.
17	The sum appropriated shall be expended by the department of
18	agriculture for the purposes of this Act.
19	SECTION 3. This Act shall take effect on July 1, 2011.
