BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 237D-2, Hawaii Revised Statutes, is
2	amended by amending subsection (b) to read as follows:
3	"(b) There is levied and shall be assessed and collected
4	each month an additional:
5	(1) One per cent for the period beginning July 1, 2009, to
6	June 30, 2010; and
7	(2) Two per cent for the period beginning July 1, 2010, to
8	June 30, 2015;
9	on the gross rental or gross rental proceeds derived from
10	furnishing transient accommodations[-] or on the fair market
11	value of transient accommodations that are furnished on a
12	complimentary or gratuitous basis, or otherwise at no charge,
13	including as part of a package or in exchange for nonmonetary
14	consideration; provided that the total rate levied and assessed
15	for a transient accommodation that is furnished at no charge
16	shall be the greater of \$10 per day or the sum of the applicable
17	tax rates under subsection (a) and this subsection. The rate

7	237D-2 [and 237D-6.5], Hawaii Revised Statutes, shall be
8	reenacted in the form in which [they] <u>it</u> read on June 30,
9	2009[$-$], as further amended by section 1 of Act , Session
10	Laws of Hawaii 2011; and section 237D-6.5, Hawaii Revised
11	Statutes, shall be reenacted in the form in which it read on
12	June 30, 2009."
