## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 103B-3, Hawaii Revised Statutes, is

11	2. By amending subsections (c) and (d) to read:

13	the entire duration of the contract.] Certification of		
14	compliance with this chapter shall be made under oath by an		
15	officer of the general contractor and applicable subcontractor		
16	to the procurement officer [on a monthly basis.] with the notice		
17	of completion of the contract.

Specifies certain sanctions for general contractors and subcontractors who fail to comply with Chapter 103B, HRS. Effective July 1, 2050. (SB1221 HD1)
