A BILL FOR AN ACT

RELATING TO THE ALOHA TOWER DEVELOPMENT CORPORATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART 1
2	SECTION 1. Chapter 206E, Hawaii Revised Statutes, is
3	amended by adding a new section to be appropriately designated
4	and to read as follows:
5	"§206E- Aloha Tower complex. The district shall also
6	include the Aloha Tower complex identified as the area bounded
7	by Nimitz highway beginning at its intersection with the Diamond
8	Head boundary of tax map key 2-1-13:7 north along Nimitz highway
9	to its intersection at pier 11 and Nimitz highway; southwest
10	along the face of piers 10 and 11; southeast along the face of
11	pier 9; northeast along the face of pier 8; southeast parallel
12	along the revetment of Ala Moana boulevard and to include pier
13	7; southwest along pier 6 and its shoreline and around to pier 5
14	and its shoreline; northeast to Ala Moana boulevard; north along
15	Nimitz highway to its intersection with Richards street;
16	southwest along Richards street to its intersection with Ala
17	Moana boulevard; northwest along Ala Moana boulevard to its
18	intersection with the Ewa boundary of tax map key 2-1-14:6;

1	northeast along the Ewa boundary of tax map key 2-1-14:6 to its
2	Ewa mauka corner; and northwest across Bishop street to the
3	point of beginning at the intersection of the Diamond Head
4	boundary of tax map key 2-1-13:7 and Nimitz highway."
5	PART II
6	SECTION 2. Chapter 266, Hawaii Revised Statutes, is
7	amended by adding a section to be appropriately designated and
8	to read as follows:
9	" <u>\$266-</u> Implementation of the commercial harbors
10	modernization plan. (a) No later than July 1, 2010, the
11	implementation of the commercial harbors modernization plan
12	shall be the responsibility of the department of
13	transportation. All projects, prior to implementation, shall be
14	approved by the governor."
15	PART III
16	SECTION 3. There is appropriated out of the Aloha Tower
17	fund the sum of \$ or so much thereof as may be
18	necessary for fiscal year 2011-2012 for operating expenses.
19	The sum appropriated shall be expended by the Hawaii
20	community development authority for the purposes of this Act.
21	SECTION 4. Except as otherwise provided in this Act, all
22	rights, powers, functions, and duties of the Aloha Tower

development corporation are transferred to the Hawaii community
development authority.

3 SECTION 5. All appropriations, records, equipment, 4 machines, files, supplies, contracts, leases, books, papers, 5 documents, maps, and other personal property heretofore made, 6 used, acquired, or held by the Aloha Tower development 7 corporation shall be transferred to the Hawaii community 8 development authority. 9 SECTION 6. The Aloha Tower fund created by section 206J-10 17, Hawaii Revised Statutes, shall be transferred to the Hawaii

11 community development authority. All moneys, rentals, charges, 12 and other revenues from the Aloha Tower complex shall be 13 deposited into the fund.

SECTION 7. Chapter 206J, Hawaii Revised Statutes, isrepealed.

16 SECTION 8. New statutory material is underscored.

17 SECTION 9. This Act shall take effect on July 1, 2011.
