## A BILL FOR AN ACT

RELATING TO THE HAWAII HURRICANE RELIEF FUND.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Hawaii is facing one of the most challenging 2 economic periods in its history. Current economic conditions 3 have necessitated difficult decisions by the State to balance an 4 already precarious budget. The reduction in force in state 5 government has reduced services to the public and has also had 6 an adverse effect on the efficiency and effectiveness of certain 7 key operational areas. Funding reductions have also impacted the State's ability to provide services to those who are most 8 9 vulnerable to setbacks during this time of economic 10 uncertainties and has affected the State's ability to fuel and 11 sustain an economic recovery.

12 The State's options for balancing the budget have, for the 13 most part, been exercised. This has resulted in negatively 14 impacting the ability of state agencies to sustain the delivery 15 of core services to the public and to other state agencies. 16 The purpose of this Act is to appropriate Hawaii hurricane 17 relief fund moneys into the general fund to make funds available 18 to balance the State's budget for fiscal year 2011-2012 and SB1270 SD2 LRB 11-2249.doc

maintain the levels of programs determined to be essential for
education, public health, and public welfare.

3 SECTION 2. Notwithstanding provisions of chapter 431P, 4 Hawaii Revised Statutes, to the contrary, there is appropriated 5 out of the Hawaii hurricane relief fund the sum of \$ 6 or so much thereof as may be necessary for fiscal year 2011-2012 7 to be deposited into the general fund to balance the State's 8 budget and maintain the levels of programs determined to be 9 essential for education, public health, and public welfare; 10 provided that there shall remain a balance of no less than \$ 11 in the Hawaii hurricane relief fund; and provided further 12 that the Hawaii hurricane relief fund shall be reimbursed for 13 the sum appropriated under this section using general fund 14 moneys according to a repayment schedule determined by the 15 director of budget and finance that shall begin no later than 16 fiscal year 2013-2014.

SECTION 3. This Act shall take effect on July 1, 2050.
