### A BILL FOR AN ACT

RELATING TO THE CERTIFICATION OF PRINCIPALS AND VICE-PRINCIPALS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the department of 2 education currently has requirements for the certification of its principals and vice-principals. The legislature also finds 3 that the federal American Recovery and Reinvestment Act of 2009 4 provides educational funds for states that pursue educational 5 reform and additional funds for those states that qualify for 6 Race to the Top funds by advancing educational reform. One of 7 the selection criteria for the Race to the Top funds is 8 9 providing alternative routes to certification for teachers and 10 principals. Although the legislature previously amended section 302A-605, Hawaii Revised Statutes, to allow for the 11 establishment of alternative routes to certification, the 12 current requirement for a principal candidate to possess not 13 less than five years of appropriate school-level experience, of 14 which at least three years shall have been as a teacher, is too 15 restrictive and conflicts with the Race to the Top grant 16 17 requirements.

Statutes (HRS). Although the legislature in the last session amended section 302A-605, Hawaii Revised Statutes, to allow for the establishment of alternative routes to certification, the current requirement that an individual to

possess not less than five years of appropriate school-level experience of which at least three years shall have been a teacher is too restrictive and conflicts with the Race to the Top grant requirements. This bill will add additional language that will allow the department to determine what would qualify as appropriate equivalent experience. Such a determination would be made through the administrative rule making process under chapter 91.

Impact on the public: This would allow other individuals who may not have three years as a teacher to potentially qualify to be certified as a principal or vice principal.

Impact on the department and other agencies: This legislation will ensure the Department will meet its obligations under the federal Race to the Top grant.
