BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 27-43, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 §27-43 Information technology; chief information officer;
- 4 information technology steering committee; establishment;
- 5 **responsibilities**. (a) There is established within the office
- 6 of the governor a full-time chief information officer to
- 7 organize, manage, and oversee statewide information technology
- 8 governance[, including supervision and oversight of the
- 9 information and communication services division of the
- 10 department of accounting and general services]. The chief
- 11 information officer shall be appointed by the governor as
- 12 provided in section 26-34. The chief information officer shall
- 13 report directly to the governor and, in conjunction with the
- 14 information technology steering committee, shall:
- 15 (1) Develop, implement, and manage statewide information
- 16 technology governance;

1 Ensuring technology projects are selected based on 2 their potential impact and risk to the State, as well as their 3 strategic value; 4 Ensuring that executive branch departments maintain 5 sufficient tools to assess the value and benefits of technology 6 initiatives; 7 Assisting the chief information officer in developing 8 state information technology standards and policies; and 9 (6) Clarifying the roles, responsibilities, and authority 10 of the information and communication services division, 11 specifically as it relates to its statewide duties. 12 The members of the information technology steering 13 committee shall be appointed by the senate president and speaker 14 of the house of representatives in equal number respectively and 15 shall include representatives from executive branch departments, 16 including large user agencies such as the department of 17 education and the University of Hawaii; the judiciary; the 18 legislature; and private individuals. ensure that the committee is evaluated periodically.

PURPOSE:

Transfers funds into the Shared Services Special Fund, establishes the Information Technology Steering Committee Trust Account, removes chief information officer's (CIO) oversight of the information and communication services division in the department of accounting and general services, and sunsets this bill on June 30,

2013.

MEANS:

Amend Hawaii Revised Statues 27-43.

JUSTIFICATION:

Act 200, SLH 2010 created the CIO position and outlined the basic responsibilities of the position. Funds have been transferred into the special fund to carry out this the provisions in this bill. A trust fund has been established for the receipt of grants and donations to supplement funding. The development of a strategic plan will become the basis of the long term organizational structure for the CIO and required funding to implement the Plan. The revision represents the interim step required by the CIO to complete the Plan.

Impact on the public: Improve service to the public by leveraging technology to increase employee efficiency and reduce service times.

Impact on the department and other agencies:
Leveraging technology through the
utilization of a centralized information
system(s) will increase employee efficiency
and improve service delivery to the public.
It will also enhance communication between
departments through interactive computer
systems versus the current silo approach.
The long term approach will also establish
