A BILL FOR AN ACT

RELATING TO THE ATTORNEY GENERAL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 28, Hawaii Revised Statutes, is amended
 by adding a new section to be appropriately designated and to
 read as follows:

4 "<u>\$28-</u> Attorney general operations special fund. (a)
5 There is established in the state treasury the attorney general
6 operations special fund. The attorney general operations
7 special fund shall be administered by the department of the
8 attorney general. Any law to the contrary notwithstanding, the
9 moneys in the fund shall be used to fund the operations of the
10 department.

(b) Within the attorney general operations special fund
shall be the antitrust trust subaccount. The following amounts
shall be deposited into the antitrust trust subaccount:

14 (1) Ten per cent of any antitrust judgment or settlement
15 received by the State except where the deposit is
16 inconsistent with the court order or settlement
17 agreement relating to the amount; and

18 (2) Appropriations made by the legislature.

1 amount to be deposited to the credit of the department 2 of the attorney general's tobacco enforcement [special 3 fund;] subaccount; 4 provided that the department by rule may modify the stamp fee to 5 reflect actual costs incurred by the State in providing the 6 stamps." 7 Section 245-41, Hawaii Revised Statutes, is SECTION 4. 8 amended by amending subsection (c) to read as follows: 9 "(C) Where the attorney general initiates and conducts an 10 investigation resulting in the imposition and collection of a 11 criminal fine pursuant to this part, one hundred per cent of the 12 fine shall be distributed to the attorney general to be 13 deposited to the credit of the department of the attorney 14 general's tobacco enforcement [special fund;] subaccount; 15 provided that if the attorney general engages the prosecuting 16 attorney for the investigation or prosecution, or both, 17 resulting in the imposition and collection of a criminal fine 18 under this part, the fine shall be shared equally between the 19 attorney general and the prosecuting attorney." 20 SECTION 5. Section 28-13, Hawaii Revised Statutes, is 21 repealed.
