A BILL FOR AN ACT

RELATING TO FEES FOR HABITAT CONSERVATION PLANS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii hosts the
- 2 greatest concentration of threatened and endangered species in
- 3 the country. Increased development throughout the State, while
- 4 beneficial to the State in many regards, has the potential to
- 5 negatively affect threatened and endangered species. The
- 6 legislature has provided a means to permit desirable activities
- 7 that may cause incidental take of threatened and endangered
- 8 species through the establishment of incidental take licenses
- 9 and habitat conservation plans pursuant to chapter 195D, Hawaii
- 10 Revised Statutes.
- 11 Incidental take licenses authorize take of threatened and
- 12 endangered species in cases where take is incidental to an
- 13 otherwise lawful activity, provided that the applicant obtains
- 14 approval of a habitat conservation plan that identifies and
- 15 implements measures to avoid, minimize, mitigate, and monitor
- 16 take of those species, and that will increase the likelihood of
- 17 recovery of the endangered or threatened species that are the
- 18 focus of the plan.

- 1 The department of land and natural resources is responsible
- 2 for evaluating, processing, and approving habitat conservation
- 3 plans and incidental take licenses to ensure compliance with
- 4 requirements under chapter 195D, Hawaii Revised Statutes.
- 5 Chapter 195D, Hawaii Revised Statutes, provides that the
- 6 department may establish a technical assistance program to
- 7 assist landowners with habitat conservation plans. The
- 8 department has established such a program, and the technical
- 9 assistance that is required is specialized in nature and labor
- 10 intensive, requiring consultation with expert staff, endangered
- 11 species biologists, and land managers.
- The number of applications for incidental take licenses and
- 13 requests for technical assistance related to habitat
- 14 conservation plan has increased significantly in recent years.
- 15 The demand for the technical assistance program cannot be met
- 16 under the department's current budget.
- 17 The purpose of this Act is to authorize the department of
- 18 land and natural resources to collect fees to cover the
- 19 technical assistance program costs associated with assisting
- 20 landowners in the development, review, and monitoring of habitat
- 21 conservation plans, and adopt rules for establishing such fees.

- 1 SECTION 2. Section 195D-2, Hawaii Revised Statutes, is 2 amended by adding a new definition to be appropriately inserted
- 3 and to read as follows:
- 4 "Technical assistance program" means department staff
- 5 <u>designated to assist landowners in developing</u>, reviewing, or
- 6 monitoring habitat conservation plans by providing technical
- 7 assistance."
- 8 SECTION 3. Section 195D-23, Hawaii Revised Statutes, is
- 9 amended by amending subsection (d) to read as follows:
- "(d) The department may establish a habitat conservation
- 11 technical assistance program to assist landowners in developing,
- 12 reviewing, or monitoring habitat conservation plans by providing
- 13 technical assistance. The department may collect fees to cover
- 14 the technical assistance program costs, and shall adopt rules
- 15 for establishing such fees."
- SECTION 4. Section 195D-31, Hawaii Revised Statutes, is
- 17 amended by amending subsection (a) to read as follows:
- "(a) There is established within the state treasury a
- 19 trust fund to be known as the endangered species trust fund to
- 20 be administered by the department to implement the purposes of
- 21 this chapter.

Description:

Authorizes the Department of Land and Natural Resources to collect fees to cover the technical assistance program costs associated with Habitat Conservation Plans, and adopt rules for establishing such fees.

TITLE:

PURPOSE:

To authorize the Department to collect fees sufficient to cover the technical assistance

program costs associated with habitat conservation plans, and adopt rules for

establishing such fees.

MEANS:

Amend sections 195D-2, 195D-23(d), and

195D-31(a), Hawaii Revised Statutes.

JUSTIFICATION:

The Department's Division of Forestry and Wildlife (Division) continues to be approached by applicants for Habitat Conservation Plans (HCP), in an amount that is increasing rapidly and well beyond the capacity of the Department to provide timely processing of requests. The Division provides technical assistance to HCP applicants to ensure they provide measures for avoidance, minimization, mitigation, and monitoring of take of endangered species. As the number of HCP applications and issuance of incidental take licenses increase, the Division's staff time associated with technical assistance is growing enormously. At present, the Department is able to collect fees from HCP applicants only for compliance monitoring after approval of a HCP.

This bill would authorize the Department to collect fees sufficient to cover the technical assistance program costs associated with habitat conservation plans, and adopt rules for establishing such fees.

Impact on the public: This bill would benefit the public through the enhancement of the HCP program and the Department's increased ability to provide technical

assistance to the public related to HCPs,

thereby contributing to the timely

permitting of economic and renewable energy

projects that contribute to the State's

economic and energy security.

Impact on the department and other agencies:

This bill will strengthen the Department's

efforts to develop HCPs.
