## A BILL FOR AN ACT

RELATING TO MOTOR VEHICLE REGISTRATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 249-31, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "\$249-31 State registration fee. (a) All vehicles and
- 4 motor vehicles in the State as defined in section 249-1,
- 5 including antique motor vehicles, except as otherwise provided
- 6 in sections 249-4 and 249-6, shall be subject to a [\$25] \$45
- 7 annual vehicle registration fee. The fee shall be paid each
- 8 year together with all other taxes and fees levied by this
- 9 chapter on a staggered basis as established by each county as
- 10 authorized by section 286-51, and the state registration for
- 11 that county shall likewise be staggered so that the state
- 12 registration fee is due and payable at the same time and shall
- 13 be collected together with the county fee. The state
- 14 registration fee shall be deemed delinquent if not paid with the
- 15 county registration fee. The respective counties shall collect
- 16 this fee together with the vehicle registration tax collected
- 17 for the county and shall transfer the moneys collected under
- 18 this section to the State.

4	SECTION 2. There is appropriated out of the state highway

8	maintenance of the state highways program.
9	The sums appropriated shall be expended by the department

PURPOSE:

To provide the Department of Transportation with the resources needed to accomplish their primary mission and goals by increasing the state motor vehicle registration fee.

MEANS:

Amend section 249-31, Hawaii Revised

Statutes.

JUSTIFICATION:

To meet the economic needs of the State and preserve the unique quality of life of its residents and visitors to these precious islands, the department of transportation must provide a safe, efficient, and effective land transportation system for the movement of people and goods. The state land transportation system, however, has not kept pace with our growing economy, land use development patterns, and increased demand for travel. Programmatic and project needs far exceed the available resources. The land transportation system will continue to deteriorate as demand for travel continues to increases; and costs to manage, construct, and administer the system increase.

#### Impact on the public:

The estimated cost impact on the motoring public is an increase of \$20 for each registered motor vehicle. The state motor vehicle registration fee is an annual flat rate fee.

Impact on the department and other agencies:
The increase in revenues for the State
Highway Fund will improve the Department's
ability to construct, operate and maintain
the State Highway System. This would enable
the Department to increase the highways
Capital Improvement Projects (CIP) and

special maintenance programs. The failure of the State to properly maintain the State Highway System may result in sanctions by the Federal Highway Administration (FHWA), including the loss of federal funds.

The increase in revenues will also improve the department of transportation's ability to provide state matching funds for the highways federal-aid program. The normal federal share for projects on the interstate system is 90 percent, and for other eligible roadways, it is 80 percent.

The state vehicle registration fee is collected by the counties and deposited into the State Highway Fund.
