RELATING TO AGRICULTURE.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Chapter 141, Hawaii Revised Statutes, is	
2	amended b	y adding a new section to be appropriately designated	
3	and to read as follows:		
4	" <u>§14</u>	1- State matching funds program; county	
5	expenditu	res to support agriculture; special fund. (a) The	
6	departmen	t shall establish a program to provide state matching	
7	funds to	counties that expend county funds for positions or	
8	other expenses incurred to support agriculture in their		
9	respectiv	e counties. The department shall establish appropriate	
10	procedure	s, standards, and criteria for determining:	
11	(1)	County expenditures that qualify for state matching	
12		funds and the ratio of state matching funds to be	
13		provided for each dollar expended by the counties;	
14	(2)	The most appropriate way to distribute available funds	
15		to the counties if requests for state matching funds	
16		exceed the funding available; and

3	(b) There is established within the state treasury the		
4	state matching funds for county agricultural support special		
5	fund, which shall be administered by the department and into		
6	which shall be deposited legislative appropriations, grants,		
7	gifts, all interest earned or accrued on moneys deposited in the		
8	fund, and any other moneys made available to the fund. The		
9	state matching funds for county agricultural support special		
10	fund shall be used to provide state matching funds under the		
11	program specified in subsection (a)."		
12	SECTION 2. There is appropriated out of the general		
13	revenues of the State of Hawaii the sum of \$ or so		
14	much thereof as may be necessary for fiscal year 2011-2012 and		
15	the same sum or so much thereof as may be necessary for fiscal		
16	year 2012-2013 to be deposited into the state matching funds for		
17	county agricultural support special fund.		
18	SECTION 3. There is appropriated out of the state matching		
19	funds for county agricultural support special fund the sum of		
20	\$ or so much thereof as may be necessary for fiscal		
21	year 2011-2012 and the same sum or so much thereof as may be		
22	necessary for fiscal year 2012-2013 for the purposes of the
