A BILL FOR AN ACT

RELATING TO LIVESTOCK.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Fresh pork and beef provide essential 1 nutritional needs to consumers. Because these food products are 2 perishable, there is a constant risk of food spoilage caused by 3 long transports that, in turn, can cause food-borne illnesses to 4 The development of a sustainable meat processing 5 consumers. industry is vital for Hawaii's consumers and visitors. 6 Hawaii Livestock Cooperative owns the newest slaughter 7 facility in the State, which is the only such facility on Oahu. 8 The facility currently processes eight hundred hogs per month 9 and supplies various markets throughout the State. However, the 10 Hawaii Livestock Cooperative's slaughter facility is in danger 11 of filing for bankruptcy and leaving Oahu, the State's largest **12** market, without a slaughter facility. 13 With financial support, Hawaii Livestock Cooperative will

- 3 The purpose of this Act is to appropriate funds to Hawaii
- 4 Livestock Cooperative, which will serve a public purpose by
- 5 enabling the cooperative's slaughter facility to stabilize their
- 6 operations.
- 7 SECTION 2. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$ or so
- 9 much thereof as may be necessary for fiscal year 2011-2012 as a
- 10 grant pursuant to chapter 42F, Hawaii Revised Statutes, to the
- 11 Hawaii Livestock Cooperative to make investments in modern
- 12 equipment, expand and improve their stock of animals, develop
- 13 new markets and products, and take other necessary action to
- 14 stabilize its slaughter facilities operations.
- The sum appropriated shall be expended by the department of
- 16 agriculture for the purposes of this Act.
- 17 SECTION 3. The Hawaii Livestock Cooperative shall prepare
- 18 a report detailing a sustainable business plan that includes:
- 19 (1) Planned uses of the funds received pursuant to section
- 20 2;
- 21 (2) Pro forma financial statements; and
- 22 (3) Commitments from various meat industry stakeholders.



- 1 The Hawaii Livestock Cooperative shall submit the report to the
- 2 legislature no later than twenty days prior to the convening of
- 3 the 2012 regular session.
- SECTION 4. This Act shall take effect on July 1, 2011. 4
