A BILL FOR AN ACT

RELATING TO MOTOR VEHICLE INSPECTIONS,

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that particle pollution 2 is one of the most significant health risks facing the nation 3 and is increasingly worsening. Particle pollution consists of 4 airborne particles that cannot be seen with the naked eye and is 5 the main ingredient of haze. These particles present serious 6 year-round air quality problems, and can cause severe health 7 problems by settling deep into the lungs, which precipitates 8 respiratory diseases and even death. Particulate pollution is 9 regulated under the Clean Air Fine Particle Implementation Rule, 10 40 Code of Federal Regulations Part 51.

11 The Environmental Protection Agency's PM2.5 standard 12 relates to the release of airborne particles generally less than 13 or equal to 2.5 micrometers in diameter. One of the main 14 sources of fine particle pollution is the release of PM2.5 from 15 tire wear, brake wear, road materials, and tail pipe emissions 16 from cars and trucks. PM2.5 remains on the roadways as part of 17 road dust. Tires impact and scatter the PM2.5 into the air.

PM2.5, which contains metals and toxics, also washes into storm
 drains and pollutes the water supply.

3 The University of Hawaii civil and environmental engineering department is completing a project entitled 4 5 "Performance of Pollutant-Sorbing Filter Pads: Phase I". This 6 project is developing standard protocols for the testing and 7 evaluation of the efficiency of a new invention, the StreetVac 8 system, which is a filter device installed in vehicle wheel wells to capture pollutants, including fine particulate matter, 9 10 emitted by vehicles or already present on roadways and made 11 airborne by vehicle traffic. The results of the work of the 12 University of Hawaii should be a model suitable for use by Hawaii and other states when estimating the value of StreetVac 13 14 and similar devices in reducing air pollution from fine 15 particulate matter. Testing thus far has revealed that the 16 portion of fine particulate matter collected by StreetVac on 17 roadways is measurable and significant.

18 The purpose of this Act is to require motor vehicles to be 19 equipped with a road pollution filter as a condition precedent 20 to the issuance of a certificate of inspection.

21 SECTION 2. Section 286-26, Hawaii Revised Statutes, is

1 By amending subsection (b) to read: 1. 2 "(b) All other vehicles, including motorcycles, trailers, 3 semitrailers, and pole trailers having a gross vehicle weight 4 rating of 10,000 pounds or less, and antique motor vehicles as 5 defined in section 249-1, except those in subsections (c) and 6 (d), shall be certified as provided in subsection (e) every 7 twelve months; provided that any vehicle to which this 8 subsection applies shall not require inspection within two years 9 of the date on which the vehicle was first sold [-] if the 10 vehicle is equipped in each wheel well with a wheel well filter 11 device that is approved by the director of transportation and 12 captures air pollutants, such as metals and fine particulate 13 matter, as provided in 40 Code of Federal Regulations Part 51, 14 emitted by the vehicle or already present on roadways." 15 2. By amending subsection (g) to read: 16 "(q) The director of transportation shall adopt necessary rules for the administration of inspections and the issuance of 17 18 certificates of inspection [-]; provided that beginning July 1, 19 2012, no certificate of inspection shall be issued as required 20 under this part, for any vehicle not equipped in each wheel well 21 with a wheel well filter device that is approved by the director 22 of transportation and captures air pollutants, such as metals 2011-0050 SB SMA-1.doc

and fine particulate matter, as provided in 40 Code of Federal 1 2 Regulations Part 51, emitted by vehicles or already present on 3 roadways." 4 SECTION 3. Statutory material to be repealed is bracketed 5 and stricken. New statutory material is underscored. 6 SECTION 4. This Act shall take effect upon its approval. 7
