A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR THE RENOVATION OF THE AUDITORIUM AT KAWANANAKOA MIDDLE SCHOOL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that Prince David
Kawananakoa middle school is located on the outskirts of
downtown Honolulu. It was established in 1927 as an
experimental school with curriculum for Hawaii's children.
Currently, the school serves students from grades six through
eight with an enrollment of approximately eight hundred
students.

8 The legislature finds that Kawananakoa middle school was 9 awarded the prestigious national Blue Ribbon School Award in 10 2007. It continues to receive numerous awards and recognitions 11 in band, spelling bees, math competitions, poetry, art, and 12 multimedia contests.

13 The legislature also finds that Kawananakoa middle school 14 wishes to accentuate the rich culture and history of its campus 15 by preserving, repairing, and enhancing its campus architecture. 16 This includes a renovation of the school's auditorium. The Page 2

1 legislature finds that the auditorium was built in 1936, and is 2 in need of significant repairs.

3 The legislature further finds that Act 180, Session Laws of 4 Hawaii 2010, appropriated \$900,000 through item G-48 for the 5 design of the renovation of the auditorium of Kawananakoa middle 6 school, but the funds have not been released. The estimated 7 total cost for the project is \$14,000,000.

8 The purpose of this Act is to appropriate moneys for the 9 capital improvement project for the renovation of the auditorium 10 at Kawananakoa middle school.

SECTION 2. There is appropriated out of the general 11 12 revenues of the State of Hawaii the sum of \$14,000,000 or so 13 much thereof as may be necessary for fiscal year 2011-2012 for 14 the capital improvement project for the renovation of the 15 auditorium at Kawananakoa middle school.

16 The sum appropriated shall be expended by the department of 17 education for the purposes of this Act.

18 SECTION 3. This Act shall take effect on July 1, 2011.
