## A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that in 2001, the federal
- 2 Bureau of Prisons opened a three hundred twenty-five thousand-
- 3 square-foot, \$63,000,000 detention center at 351 Elliot Street
- 4 on the island of Oahu. Constructed by Dick Pacific Construction
- 5 and located on the west side of the Honolulu international
- 6 airport, the Federal Detention Center has a capacity of six
- 7 hundred seventy beds on five levels of a seven-floor facility.
- 8 In addition, most of the beds can be converted to double bunks
- 9 to increase capacity.
- 10 The Honolulu Federal Detention Center has integrated state-
- 11 of-the-art surveillance and management technologies, allowing a
- 12 single worker to monitor a wing of sixty-four beds, and staff to
- 13 "quick freeze" individually packed meals up to forty-eight hours
- 14 in advance for refrigeration and later reheating and serving.
- 15 Furthermore, because of its location within urban Honolulu,
- 16 high visibility from the H-1 freeway, local roads nearby, and
- 17 air traffic landing and taking off within its vicinity, the
- 18 Honolulu Federal Detention Center was designed to meet all



- 1 federal correctional facility standards without looking like a
- 2 prison. It was also designed to accommodate a wide variety of
- 3 uses, including inmate cells, office areas, medical facilities,
- 4 recreational areas, storage rooms, food preparation areas,
- 5 laundry, mechanical rooms, security, and communications.
- 6 The entire center consists of two buildings:
- 7 (1) A twelve-story main tower with a two-story
- 8 administration base; and
- 9 (2) A single-story warehouse and receiving building.
- 10 The center also includes a one hundred eighty-two-stall
- 11 parking area fronting the main tower.
- 12 The purpose of this Act is to direct the department of
- 13 public safety and department of accounting and general services
- 14 to plan and design the construction and operation of a new
- 15 minimum-security facility that either includes or is located at
- 16 a site with appropriate access to courts, public transportation,
- 17 drug rehabilitation centers, transitional or reintegration
- 18 programs, and other support services, similar to the facilities
- 19 of the Honolulu Federal Detention Center, to manage the
- 20 continued growth of Hawaii's inmate population.
- 21 SECTION 2. The department of public safety and the
- 22 department of accounting and general services shall plan and

- 1 design the construction and operation of a new minimum-security
- 2 facility at the site of the existing Oahu community correctional
- 3 center, similar to the facilities of the Honolulu Federal
- 4 Detention Center. The department of public safety shall submit
- 5 a status report to the legislature no later than twenty days
- 6 before the convening of the 2012 regular session, setting forth
- 7 the results and recommendations of the plan, including:
- **8** (1) Transitional housing of inmates while construction of
- 9 the new facility takes place; and
- 10 (2) The cost of preparing an environmental impact
- 11 statement in accordance with chapter 343.
- 12 SECTION 3. The director of finance is authorized to issue
- 13 general obligation bonds in the sum of \$ or so much
- 14 thereof as may be necessary and the same sum or so much thereof
- 15 as may be necessary is appropriated for fiscal year 2011-2012
- 16 for the planning and design of a minimum-security correctional
- 17 facility at the site of the Oahu community correctional center.
- 18 SECTION 4. The appropriation made for the capital
- 19 improvement project authorized by this Act shall not lapse at
- 20 the end of the fiscal biennium for which the appropriation is
- 21 made; provided that all moneys from the appropriation
- 22 unencumbered as of June 30, 2014, shall lapse as of that date.

- 1 The sum appropriated shall be expended by the department of
- 2 public safety for the purposes of this Act.
- 3 SECTION 5. This Act shall take effect on July 1, 2011.
