BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 348-8, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows: 3 "(a) There is established within the department a state rehabilitation council. The council shall consist of [twenty-4 5 one] fifteen members appointed by the governor as provided in 6 section 26-34 and without regard to section 78-4. The members 7 shall include: 8 At least one representative of a parent training and (1) information center; 9 10 (2) At least one representative of the client assistance 11 program; 12 At least one qualified vocational rehabilitation (3) 13 counselor with knowledge of and experience with vocational rehabilitation programs, who shall serve as 14 15 an ex officio, nonvoting member if employed by the vocational rehabilitation division of the department; 16 17 At least one representative of community rehabilitation program service providers; 18

- 6 filled in the same manner as the original appointment, except
- 7 that the governor may delegate the authority to fill such a
- 8 vacancy to the remaining members of the council after making the
- 9 original appointment."
- 10 SECTION 2. Statutory material to be repealed is bracketed
- 11 and stricken. New statutory material is underscored.
- 12 SECTION 3. This Act shall take effect upon its approval.
