A BILL FOR AN ACT

RELATING TO THE PETROLEUM INDUSTRY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 486H-13, Hawaii Revised Statutes, is
 amended to read as follows:

3 "§486H-13 Maximum pre-tax wholesale price for the sale of 4 **gasoline; civil actions.** (a) Notwithstanding any law to the 5 contrary, no manufacturer, wholesaler, or jobber may sell 6 regular unleaded, mid-grade, or premium gasoline to a dealer 7 retail station, an independent retail station, or to another jobber or wholesaler at a price above the maximum pre-tax 8 9 wholesale prices established pursuant to subsection (b). The 10 commission shall publish the maximum pre-tax wholesale prices by 11 means that shall include the internet website for the State of 12 Hawaii.

(b) On a weekly basis, the commission shall determine the
maximum pre-tax wholesale price of regular unleaded, mid-grade,
and premium gasoline as follows: the maximum pre-tax wholesale
price of regular unleaded gasoline shall consist of the baseline
price for regular unleaded gasoline, plus the marketing margin
factor and the zone price adjustment, and for mid-grade and

1 premium gasoline, the applicable mid-grade and premium 2 adjustment factor, such that the maximum pre-tax wholesale 3 gasoline prices reflect and correlate with competitive market 4 conditions.

5 (c) The baseline price for regular unleaded gasoline
6 referred to in subsection (b) shall be determined on a weekly
7 basis and shall be equal to the average of the three lowest of
8 the four weekly averages of the spot daily price for
9 conventional regular unleaded gasoline or its equivalent
10 standard:

- 11 (1) The weekly average of the spot daily price for
 12 conventional regular unleaded gasoline for Los
 13 Angeles;
- 14 (2) The weekly average of the spot daily price for
 15 conventional regular unleaded gasoline for New York
 16 Harbor;
- 17 (3) The weekly average of the spot daily price for
 18 conventional regular unleaded gasoline for the United
 19 States Gulf Coast; and
- 20 (4) The weekly average of the spot daily price for
 21 conventional regular unleaded gasoline for Singapore,



1 as reported and published by the Oil Price Information Service 2 for the five business days of the preceding week; provided that 3 if the preceding week contains a holiday or holidays, then the 4 average of the remaining business days of the preceding week 5 shall be used; and provided further that the commission, in its 6 discretion, may determine a more appropriate baseline or a more 7 appropriate price information reporting service or use multiple 8 price information reporting services.

9 (d) The marketing margin factor referred to in subsection
10 (b) shall be 14 cents per gallon or as otherwise determined by
11 the commission and shall thereafter be subject to adjustment
12 pursuant to section 486H-16(a).

(e) The mid-grade adjustment factor shall be 5 cents per
gallon or as otherwise determined by the commission and shall
thereafter be subject to adjustment pursuant to section 486H16 (a).

17 (f) The premium adjustment factor shall be 9 cents per
18 gallon or as otherwise determined by the commission and shall
19 thereafter be subject to adjustment pursuant to section 486H20 16(a).

1 (2)Twenty per cent of the zone price adjustment shall be 2 allocated to the terminal holding the gasoline in 3 zones 2 through 8; and 4 (3)Fifty per cent of the zone price adjustments shall be 5 allocated to the person or entity that delivers the 6 gasoline to the retail station in zones 2 through 8. 7 Every manufacturer, wholesaler, or jobber[, upon the (j) 8 request of the commission,] shall furnish to the commission, at 9 weekly intervals and in the form [requested,] prescribed by the 10 commission, all documents, data, and information the commission 11 may require to make its determination on zone price 12 adjustments [-]; provided that the documents, data, and 13 information shall also be submitted to the commission at any 14 time the commission so requests. 15 Any person who refuses or fails to comply with [a-request 16 for information by the commission] this subsection shall be 17 subject to a fine of up to \$50,000 per day. Each day a 18 violation continues shall constitute a separate offense. 19 (k) The maximum pre-tax wholesale gasoline price imposed 20 by this section shall take effect on September 1, 2005, 21 notwithstanding the lack of the adoption of rules pursuant to 22 this section; provided that notwithstanding any law to the SB LRB 11-1177.doc

1	contrary, the maximum pre-tax wholesale price under this section		
2	shall be suspended indefinitely upon the effective date of Act		
3	78, Session Laws of Hawaii 2006, and shall not thereafter become		
4	effective until and unless [the governor publishes a notice		
5	statewide in accordance with section 1-28.5 that the		
6	reinstatement of the maximum pre-tax wholesale price under this		
7	section is beneficial to the economic well-being, health, and		
8	safety of the people of the State. The] the weekly average of

1 set forth above.] Upon a finding that the maximum pre-tax 2 wholesale price would impose a financial hardship upon a 3 distributor within a zone, the [governor, in the governor's 4 discretion, commission may increase the maximum pre-tax 5 wholesale price for the zone in an amount determined necessary 6 to eliminate the financial hardship on any affected distributor 7 who does not operate a refinery within the State. Any increase 8 in the maximum pre-tax wholesale price shall be included in the 9 notice published by the [governor.] commission.

10 [(1) The suspension of the maximum pre-tax wholesale

1 shall be liable for the costs of the action and reasonable 2 attorney's fees as determined by the court. Within two years 3 from the date the commission obtains actual knowledge of the 4 violation, the commission may institute a civil action in a 5 court of competent jurisdiction to collect the civil penalty, 6 the costs, and attorney's fees. In the case of ongoing 7 violation, the two-year period shall start from the date of the 8 last violation. The commission may refer any such action to the 9 attorney general as it deems appropriate. Report Title:

Gasoline Cap; Automatic Reinstatement; Reporting Requirements

Description:

Requires the statutory maximum pre-tax wholesale gasoline price (gas cap) to be automatically reinstated for one month after average weekly prices exceed the gas cap for a certain period of time. Requires zone price adjustment information to be reported regularly to PUC rather than upon request.
