## A BILL FOR AN ACT

RELATING TO PRESCRIPTION MEDICATIONS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that prior authorization
2	for prescription medications requires that physicians obtain
3	approval from a health insurance carrier to prescribe a specific
4	medication for their patients. Without this prior
5	authorization, a health insurance carrier may not provide
6	coverage for patient medication. Despite its growing visibility
7	and importance, the prior authorization process is not
8	standardized across insurers and providers and is often
9	conducted without the benefit of communications technology,
10	thereby creating unnecessary administrative burdens and costs to
11	health care providers and health insurers. The current process
12	also results in delays in filling patient prescriptions and
13	potentially adverse health effects.
14	While prescription drugs requiring prior authorization
15	constitute only a small fraction of all prescribed medications,
16	the number of drugs requiring prior authorization and the number
17	of prior authorizations required by insurers have grown rapidly

- 1 in recent years indicating that prior authorization has become a
- 2 widely used method of drug utilization management.
- 3 The legislature finds that the stakeholders in the issue of
- 4 prior authorization for prescription medications represent
- 5 important perspectives on this complex issue. Therefore, the
- 6 purpose of this Act is to convene a working group of diverse
- 7 stakeholders to consider the issue of prior authorization for
- 8 prescription medication and make recommendations for legislative
- 9 action based on consensus of the participants.
- 10 SECTION 2. (a) There is established the prescription
- 11 medication prior authorization working group to consider the
- 12 issue of insurers' prior authorization requirements for
- 13 prescription medications and make recommendations for
- 14 legislative action based on consensus of the participants. The
- 15 working group shall conduct research, assess and evaluate
- 16 policies for a standardized and expeditious policy for use by
- 17 health care and insurance providers to obtain prior
- 18 authorization for prescription medications, and make
- 19 recommendations to the legislature based on best practices. The
- 20 working group shall consider:
- 21 (1) The requirements of state and federal law relating to
- 22 prescription medications;

1	(2)	Preservation of patient confidentiality and compliance	
2		with the federal Health Insurance Portability and	
3		Accountability Act;	
4	(3)	Incorporation of electronic prescribing and electronic	
5		health records to maximize efficiency in the prior	
6		authorization process;	
7	(4)	Current prior authorization requirements of health	
8		insurers and managed care plans currently operating in	
9		the State; and	
10	(5)	Best practices of other states that have adopted	
11		policies to standardize or coordinate prior	
12		authorization policies across health care providers

14	The worki	ng group shall submit a report of its findings and	
15	recommendations, including any implementing legislation, to the		
16	legislature no later than twenty days prior to the convening of		
17	the regular session of 2012.		
18	(b)	The working group established pursuant to this Act	
19	shall be	convened by the Healthcare Association of Hawaii, which	
20	shall pro	vide the working group with meeting space and the	
21	support n	ecessary to facilitate discussion, but shall not be a	

1	participating member of the working group. The working group		
2	shall inc	lude:	
3	(1)	The director of human services, or the director's	
4		designee;	
5	(2)	A representative of the Hawai'i Health Information	
6		Exchange;	
7	(3)	A representative of pharmacists practicing within the	
8		State;	
9	(4)	A representative from each of the providers of	
10		accident and health or sickness insurance in this	
11		State, including health maintenance organizations;	
12	(5)	A representative of physicians practicing within the	
13		State;	
14	(6)	A representative of the consumer or patient advocacy	
15		community; and	
16	(7)	Any other members that the working group or its	
17		convener find necessary for the efficient operation of	
18		the working group.	
19	(c)	The working group shall cease to exist on June 30,	
20	2011.
