RELATING TO BIOFUEL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 486J, Hawaii Revised Statutes, is
amended by adding a new section to be appropriately designated
and to read as follows:

"§486J- Biofuel content requirement. (a) The director 4 shall adopt rules in accordance with chapter 91 to require that 5 fuel sold in the State for use in motor vehicles contains no 6 7 less than fifteen per cent biofuel by volume. The biofuel shall 8 be produced in the State from agricultural products grown in the State. The amounts of transportation fuel sold in the State 9 containing no less than fifteen per cent biofuel shall be in 10 accordance with rules adopted by the director to administer and 11 12 enforce this section. The director may authorize the sale of 13 fuel that does not meet these requirements as provided in 14 subsection (b). The director may authorize the sale of transportation 15 (b) 16 fuel that does not meet the provisions of this section if:

20	requireme	nts of this section shall be subject to a fine of not
21	less than	\$2 per gallon of nonconforming fuel, up to a maximum
22	of \$1,000	,000 per infraction."
