A BILL FOR AN ACT

RELATING TO BIOFUEL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 486J, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§486J- Biodiesel content requirement. (a) The
- 5 director shall adopt rules in accordance with chapter 91 to
- 6 require that, beginning July 1, 2012, diesel fuel sold in the
- 7 State for use in motor vehicles contain five per cent biodiesel
- 8 by volume. The biodiesel used to achieve the content
- 9 requirement shall be a locally-sourced product that meets or
- 10 exceeds the American Society for Testing and Materials
- 11 certification or a product designated by the director through
- 12 rules adopted in accordance with chapter 91. The amounts of
- 13 diesel fuel sold in the State containing five per cent biodiesel
- 14 shall be in accordance with rules adopted by the director to
- 15 administer and enforce this section.
- 16 (b) The director may authorize the sale of diesel fuel
- 17 that does not meet the provisions of this section if:



1	(1)	Sufficient quantities of competitively-priced
2		biodiesel produced in the State are not available to
3		meet the requirements of this section; or
4	(2)	The director determines that compliance with this
5		section would cause undue hardship.
6	(c)	Each distributor, at reporting dates established by
7	the direc	tor, shall file with the director, on forms prescribed,
8	prepared,	and furnished by the director, a certified statement
9	showing:	
10	<u>(1)</u>	The price and amount of biodiesel available;
11	(2)	The amount of biodiesel-blended fuel sold by the
12		distributor;
13	<u>(3)</u>	The amount of non-biodiesel-blended diesel fuel sold
14		by the distributor; and
15	(4)	Any other information that the director requires for
16		the purpose of compliance with this section.
17	<u>(d)</u>	Provisions with respect to confidentiality of
18	information shall be as provided in section 486J-6.	
19	<u>(e)</u>	Any distributor or any other person who violates this
20	section s	hall be subject to a fine of not less than \$2 per
21	gallon of	nonconforming fuel, up to a maximum of \$10,000 per
22	infraction.

- (f) As used in this section, "biodiesel" means a vegetable
- 2 oil-based fuel that meets or exceeds American Society for
- 3 Testing and Materials International standard D6751, "Standard
- 4 Specification for Biodiesel (B100) Fuel Blend Stock for
- 5 Distillate Fuels", as amended."
- 6 SECTION 2. New statutory material is underscored.
- 7 SECTION 3. This Act shall take effect upon its approval.
