A BILL FOR AN ACT

RELATING TO NATIVE HAWAIIAN HEALERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The Hawaii Revised Statutes is amended by
2	adding a new chapter to be appropriately designated and to read
3	as follows:
4	"CHAPTER
5	NATIVE HAWAIIAN HEALERS
6	-1 Definitions. As used in this chapter:
7	"Applicant" means an applicant for a license under this
8	chapter.
9	"Board" means the board of native Hawaiian healing.
10	"Department" means the department of commerce and consumer
11	affairs.
12	"Native Hawaiian healer" means a person who practices
13	native Hawaiian healing pursuant to a license issued under this
14	chapter.
15	"Practice of native Hawaiian healing" means personal health
16	care of individuals based on traditional native Hawaiian
17	practices including laau lapaau herbal healing, laau kahea



spiritual healing, lomi lomi massage, and hooponopono conflict
 resolution.

3 "Traditional practitioner" means a person with knowledge,
4 skills, and experience in direct personal health care of
5 individuals based on native Hawaiian practices acquired through
6 direct, practical association with native Hawaiian elders and
7 oral traditions transmitted across generations.

8 § -2 License required. No person shall practice, offer
9 to practice, or advertise the practice of native Hawaiian
10 healing in this State, whether for compensation or otherwise,
11 without a valid license issued pursuant to this chapter.

12 § -3 Scope of practice. (a) The practice of native 13 Hawaiian healing shall include personal health care based on 14 traditional native Hawaiian practices that employ laau lapaau 15 herbal healing, laau kahea spiritual healing, lomi lomi massage, 16 and hooponopono conflict resolution.

(b) The practice of native Hawaiian healing pursuant to
this chapter shall not include the provision of treatment
modalities outside of traditional Hawaiian practices and for
which a separate license is required; provided that a person
licensed pursuant to this chapter shall not be required to hold
a license under chapter 452 in order to include lomi lomi

3 § -4 Physicians and osteopathic physicians not exempt.
4 Persons licensed under chapter 453 who practice native Hawaiian
5 healing shall be subject to the requirements of this chapter.

6 § -5 Examination required. No person shall be licensed 7 under this chapter to practice native Hawaiian healing unless 8 that person has passed an examination and has been found to hold 9 the necessary qualifications as prescribed by this chapter and 10 by rules adopted by the board in accordance with chapter 91.

11 Qualifications for examination. Before any S - 6 12 applicant shall be eligible for examination under this chapter, 13 the applicant shall furnish satisfactory proof to the board that 14 the applicant has been awarded a bachelor's degree or higher 15 degree in Hawaiian studies or an equivalent degree, as 16 determined by the board pursuant to rules adopted under chapter 17 91, that includes an accredited course of study in native 18 Hawaiian healing from an accredited college or university.

19 § -7 Board of native Hawaiian healing. There shall be a
20 board of native Hawaiian healing consisting of five members
21 appointed by the governor pursuant to section 26-34 which shall
22 be attached to the department for administrative purposes only.

In addition -10 to any other actions authorized by law, the board may, after a 12 13 hearing conducted pursuant to the requirements of chapter 91, 14 revoke or suspend a license issued under this chapter for cause, 15 including but not limited to: 16 Acceptance of a fee based on an assurance that a (1)17 manifestly incurable ailment can be permanently cured by the licensee; 18 19 (2) The use of false, fraudulent, or deceptive 20 advertising, or untruthful and improbable statements;
