### A BILL FOR AN ACT

RELATING TO CRUELTY TO ANIMALS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 711-1109, Hawaii Revised Statutes, is
 amended by amending subsection (1) to read as follows:

3 "(1) A person commits the offense of cruelty to animals in
4 the second degree if the person intentionally, knowingly, or

6	(a)	Overdrives, overloads, tortures, torments, beats,
7		causes substantial bodily injury, or starves any

10	(b)	Deprives a pet animal of necessary sustenance or
11		causes such deprivation;
12	(C)	Mutilates, poisons, or kills without need any animal

13 other than insects, vermin, or other pests; provided
14 that pests do not include peacocks;

15 (d) Keeps, uses, or in any way is connected with or
16 interested in the management of, or receives money for
17 the admission of any person to, any place kept or used
