# A BILL FOR AN ACT

RELATING TO CRUELTY TO ANIMALS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 711-1109, Hawaii Revised Statutes, is
 amended by amending subsection (1) to read as follows:

3 "(1) A person commits the offense of cruelty to animals in
4 the second degree if the person intentionally, knowingly, or
5 recklessly:

- 6 (a) Overdrives, overloads, tortures, torments, beats,
  7 causes substantial bodily injury[7] to, or starves any
  8 animal, or causes the overdriving, overloading,
  9 torture, torment, beating, or starving of any animal;
  10 (b) Deprives a pet animal of necessary sustenance or
  11 causes such deprivation;
- 12 (c) Mutilates, poisons, or kills without need any animal
  13 other than insects [, vermin, or other pests;] or
  14 rodents; provided that any insects or rodents are
  15 handled in accordance with standard and acceptable
  16 insect or rodent control practices;

1 the admission of any person to, any place kept or used 2 for the purpose of fighting or baiting any bull, bear, 3 cock, or other animal, and includes every person who 4 encourages, aids, or assists therein, or who permits 5 or suffers any place to be so kept or used; 6 (e) Carries or causes to be carried, in or upon any 7 vehicle or other conveyance, any animal in a cruel or 8 inhumane manner; 9 (f) Confines or causes to be confined, in a kennel or 10 cage, any pet animal in a cruel or inhumane manner; 11 (q)Tethers, fastens, ties, or restrains a dog to a 12 doghouse, tree, fence, or any other stationary object 13 by means of a choke collar, pinch collar, or prong 14 collar; provided that a person is not prohibited from 15 using such restraints when walking a dog with a hand-16 held leash or while a dog is engaged in a supervised 17 activity; or 18 (h) Assists another in the commission of any act specified 19 in subsections (1)(a) through (1)(q)."

20 SECTION 2. This Act does not affect rights and duties that 21 matured, penalties that were incurred, and proceedings that were 22 begun before its effective date.
