A BILL FOR AN ACT

RELATING TO THE HAWAII TOBACCO SETTLEMENT SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the John A. Burns 2 school of medicine is authorized under existing statutes to use 3 a portion of Hawaii tobacco settlement special fund moneys for 4 annual operating expenses to support the school's operations and 5 train and graduate new physicians. The legislature further 6 finds that if no action is taken, the school's authorization to 7 use those funds will expire on June 30, 2011.

8 The purpose of this Act is to address the portion of Hawaii 9 tobacco settlement special fund moneys allocated to the John A. 10 Burns school of medicine by:

11 (1) Extending the authorization that allows the John A.
12 Burns school of medicine a portion of Hawaii tobacco
13 settlement special fund moneys for annual operating
14 expenses until 2015 while reducing that portion of
15 fund moneys each fiscal year until the fiscal year
16 ending on June 30, 2015;

17 (2) Establishing a school of public health;

1 A loan recipient subject to this section who fails to (d) 2 practice medicine in a rural area of the State, as designated by 3 the university, for a minimum of six consecutive years from the 4 loan recipient's original date of employment, excluding temporary leaves of absence, shall be subject to a withdrawal of 5 6 any waiver of future repayments, and shall repay any remaining 7 loan balance at the rate of ten per cent simple interest. 8 In accordance with chapter 103D, the university shall (e) enter into written contracts with collection agencies for the 9 10 purpose of collecting delinquent student loans. All payments 11 collected by a collection agency, including late fees and all 12 other reasonable costs, exclusive of the collection agency's 13 commissions, shall revert and be credited to the Hawaii medical doctor loan program special fund. A collection agency that 14 15 enters into a written contract with the university for the 16 collection of delinquent student loans, pursuant to this section, shall collect a commission from the debtor in 17 accordance with the terms of, and up to the amounts authorized 18 19 in, the written contract.

20 (f) Liability for repayment of a loan shall be canceled
21 upon the death or permanent total disability of the loan
22 recipient.



§304A-C Capacity of minors in qualifying for Hawaii 1 2 medical doctor loans. Any student otherwise qualifying for a 3 loan under the Hawaii medical doctor loan program shall not be 4 disgualified because the student is under the age of eighteen 5 years, and for the purpose of applying for, receiving, and 6 repaying the loan, the student shall be deemed to have full 7 legal capacity to act and shall have all rights, powers, 8 privileges, and obligations of an adult with respect to the 9 loan. 10 §304A-D Rules governing Hawaii medical doctor loan 11 program. Establishes a University of Hawaii School of Public Health and dedicated Special Fund. Establishes the Hawaii Medical Doctor Loan Program and dedicated Special Fund. Establishes the Hilo Medical Center Rural Interdisciplinary Residency Program and dedicated Special Fund. Deposits the decreasing annual amount into the three special funds in unspecified percentages. Effective July 1, 2050. (SB239 HD2)
