A BILL FOR AN ACT

RELATING TO THE HAWAII TOBACCO SETTLEMENT SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the John A. Burns
- 2 school of medicine is authorized under existing statute to use a
- 3 portion of Hawaii tobacco settlement special fund moneys for
- 4 annual operating expenses to support the school's operations and
- 5 train and graduate new physicians. The legislature further
- 6 finds that if no action is taken, the school's authorization to
- 7 use those funds will expire on June 30, 2011.
- 8 The purpose of this Act is to extend the authorization that
- 9 allows the John A. Burns school of medicine a portion of Hawaii
- 10 tobacco settlement special fund moneys for annual operating
- 11 expenses until 2015 while reducing the portion of fund moneys by
- 12 one per cent per fiscal year until the fiscal year ending on
- 13 June 30 2015.
- 14 SECTION 2. Section 328L-2, Hawaii Revised Statutes, is
- 15 amended by amending subsection (b) to read as follows:
- 16 "(b) The fund shall be used for the purpose of receiving,
- 17 allocating, and appropriating the tobacco settlement moneys as
- 18 follows:

(1)	Fifteen per cent shall be appropriated into the
	emergency and budget reserve fund under section
	328L-3;

- (2) Twenty-five per cent shall be appropriated to the department for purposes of section 328L-4;
- (3) Six and one-half per cent shall be appropriated into the Hawaii tobacco prevention and control trust fund under section 328L-5; and
- 9 Twenty-eight per cent shall be appropriated into the (4)10 university revenue-undertakings fund created in 11 section 304A-2167.5 to be applied to the payment of 12 the principal of and interest on, and to generate 13 required coverage, if any, for, revenue bonds issued 14 by the board of regents of the University of Hawaii to 15 finance the cost of construction of a university 16 health and wellness center, including a new medical 17 school facility, to be situated on the island of Oahu, 18 for the succeeding fiscal year; and the payment of 19 annual operating expenses incurred by the new medical 20 school facility; provided that this amount shall be 21 reduced by one per cent each fiscal year starting with 22 fiscal year 2012-2013; provided further that any

5	(5)	Twenty-five and one-half per cent shall be deposited

- 6 SECTION 5. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 6. This Act shall take effect on June 29, 2011,
- 9 and shall be repealed on June 30, 2015; provided that section
- 10 328L-2, Hawaii Revised Statutes, shall be reenacted in the form
- 11 in which it read on the day before the effective date of Act
- 12 264, Session Laws of Hawaii 2007.

Extends the appropriation by a decreasing annual amount of a portion of Hawaii tobacco settlement special fund moneys for annual operating expenses of JABSOM until June 30, 2015.
