A BILL FOR AN ACT

RELATING TO THE HAWAII TOBACCO SETTLEMENT SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the John A. Burns school of medicine is authorized under existing statutes to use a portion of Hawaii tobacco settlement special fund moneys for annual operating expenses to support the school's operations and train and graduate new physicians. The legislature further finds that if no action is taken, the school's authorization to use those funds will expire on June 30, 2011.

8 The purpose of this Act is to extend the authorization that 9 allows the John A. Burns school of medicine a portion of Hawaii 10 tobacco settlement special fund moneys for annual operating 11 expenses until 2015 while reducing the portion of fund moneys by 12 one per cent per fiscal year until the fiscal year ending on 13 June 30, 2015.

SECTION 2. Section 328L-2, Hawaii Revised Statutes, is amended by amending subsection (b) to read as follows: "(b) The fund shall be used for the purpose of receiving, allocating, and appropriating the tobacco settlement moneys as

1 moneys in excess of the amounts required under this 2 paragraph shall be transferred in the succeeding 3 fiscal year to the emergency and budget reserve fund 4 under section 328L-3; and 5 (5) Twenty-five and one-half per cent shall be deposited 6 to the credit of the state general fund [-]; provided 7 that this amount shall increase by per cent each 8 fiscal year starting with fiscal year 2012-2013." 9 SECTION 3. Act 264, Session Laws of Hawaii 2007, as 10 amended by section 22 of Act 16, Session Laws of Hawaii 2008, is 11 amended by amending section 4 to read as follows: 12 "SECTION 4. This Act shall take effect on July 1, 2007, and shall be repealed on June 30, [2011;] 2015; provided that 13 14 section 328L-2, Hawaii Revised Statutes, shall be reenacted in 15 the form in which it read on the day before the effective date 16 of this Act." 17 SECTION 4.
