# A BILL FOR AN ACT

RELATING TO CABLE TELEVISION SYSTEMS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 440G, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§440G- Designation of access organizations for public,
5	educational, or governmental access channels. (a) The director
6	may designate an access organization to oversee the development,
7	operation, supervision, management, production, and broadcasting
8	of programs of public, educational, or governmental access
9	facilities obtained under section 440G-8; provided that the
10	designation shall be exempt from chapter 103D.
11	(b) No access organization shall be designated except upon
12	written application or proposal to the director, and following a
13	public hearing on each island within the local franchise area
14	that provides opportunity for input from the public.
15	(c) In determining whether to make a designation, the
16	director shall consider:
17	(1) The content of the application or proposal;
18	(2) The public need for the proposed service;
