A BILL FOR AN ACT

RELATING TO HAWAII HEALTH CORPS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that many residents of
2	Hawaii are increasingly unable to obtain timely and appropriate
3	health care due to shortages of primary health care providers in
4	the State, including physicians, physician assistants, and nurse
5	practitioners. These shortages threaten the health of Hawaii's
6	residents and affect state health care costs. These shortages
7	have pushed the federal government to designate a number of
8	areas in the State, particularly rural areas, as medically
9	underserved areas, health professional shortage areas, or as
10	having medically underserved populations.
11	The legislature further finds that counties in the United
12	States with robust primary health care systems have lower costs
13	and improved patient outcomes. Recognizing this relationship,
14	many states have implemented budget line item support for the
15	primary care pipeline.
16	Family physicians and nurse practitioners are well suited

to rural practice due to their broad scope of clinical skills

across the life cycle, encompassing the inpatient, outpatient,

- 1 nursing home, and home setting. In addition to providing acute,
- 2 chronic, and preventive care, many family physicians and nurse
- 3 practitioners provide maternity care, family planning, and
- 4 mental health services. With this scope of practice, family
- 5 physicians and nurse practitioners are well equipped to work in
- 6 teams with other health professionals to develop fully
- 7 functioning patient-centered medical homes.
- 8 The University of Hawaii John A. Burns school of medicine,
- 9 in association with Wahiawa general hospital, conducts a fully
- 10 accredited three-year family medicine residency program. This
- 11 program has contributed over sixty family physicians who
- 12 currently work throughout the State of Hawaii.
- Since 2006, a second rural residency program model has been
- 14 under development with the John A. Burns school of medicine and
- 15 the Hilo medical center. This will be the first residency
- 16 program established on a neighbor island. In addition to
- 17 training for medical students and resident physicians, this
- 18 model rural interdisciplinary training site will include
- 19 advanced practice nursing, pharmacy, psychiatry, and other areas
- 20 of practice. It is anticipated that this rural primary care
- 21 training model can be replicated on other islands.

1	The	legislature further finds that the increasingly high
2	cost of a	physician's and nurse practitioner's professional
3	education	requires physicians and nurse practitioners to seek
4	out the h	igher incomes that allow them to repay their student
5	loans. H	owever, physician and nurse practitioner salaries in
6	rural sho	rtage areas are often lower than those in non-shortage
7	areas.	
8	Loan	repayment programs have been successfully used in
9	Hawaii to	increase the number of educators serving in hard-to-
10	fill teac	hing positions, and can also be used to encourage and
11	enable ph	ysicians, physician assistants, and nurse practitioners
12	to provid	e care in shortage areas of the State.
13	The	purpose of this Act is to:
14	(1)	Establish the Hawaii health corps, under the
15		University of Hawaii John A. Burns school of medicine,
16		to provide loan repayment for physicians, physician
17		assistants, and nurse practitioners who agree to work
18,		in a county having a shortage of physicians, physician
19		assistants, and nurse practitioners, with priority
20		given to a rural area of that particular county; and
21	(2)	Appropriate funds to increase access by medically
22		underserved resident populations to culturally

1 SECTION 2. The Hawaii Revised Statutes is amended by 2 adding a new chapter to be appropriately designated and to read 3 as follows: 4 "CHAPTER 5 HAWAII HEALTH CORPS 6 -1 Definitions. As used in this chapter, unless the 7 context requires otherwise: 8 "Loan repayment" or "repayment of loan" means the payment 9 of up to twenty per cent of a Hawaii health corps program 10 participant's health care training costs including but not 11 limited to tuition not exceeding \$35,000 per year for a maximum 12 of five years of repayment. 13 "Nurse practitioner" means a person licensed as an advanced 14 practice registered nurse under chapter 457. 15 "Physician" means a person licensed to practice medicine 16 and surgery, as required by section 453-2. **17** "Physician assistant" means a person licensed to practice medicine under the supervision of a physician or osteopathic 18 19 physician, as required by section 453-5.3. 20 "Residency" means a physician or nurse practitioner

participating in an accredited program of post graduate study.

- 3 lending financial institution whose operations are principally
- 4 conducted in Hawaii. The Hawaii rural health care provider loan
- 5 repayment program shall provide loan repayments to eligible
- 6 physicians, physician assistants, and nurse practitioners who
- 7 make the service commitment under subsection (b). The
- 8 University of Hawaii John A. Burns school of medicine and the
- 9 University of Hawaii at Manoa school of nursing and dental
- 10 hygiene shall make loan repayments directly to the financial
- 11 institution under subsection (b) to offset the loan repayment

- 6 particular county; provided that eligible physicians, physician
- 7 assistants, or nurse practitioners, as applicable, shall have
- 8 graduated from a duly accredited medical school or nursing

- 19 (d) If a Hawaii rural health care provider loan repayment
- 20 program participant fails to satisfy the recipient's service

- 22 provider loan repayment program participant shall be liable for



- 1 the repayment of the outstanding balance of the loan to the
- 2 lending financial institution under subsection (b). In
- 3 addition, the University of Hawaii John A. Burns school of

- 5 and dental hygiene may seek reimbursement for any loan repayment

- (e) In accordance with chapter 103D, the University of
- 11 Hawaii John A. Burns school of medicine and the University of
- 12 Hawaii at Manoa school of nursing and dental hygiene may enter
- 13 into written contracts with collection agencies to collect
- 14 delinquent reimbursements of loan repayments. All payments
- 15 collected, exclusive of a collection agency's commissions, shall
- 16 revert and be credited to the Hawaii health corps fund. A
- 17 collection agency that enters into a written contract with the
- 18 University of Hawaii John A. Burns school of medicine or the
- 19 University of Hawaii at Manoa school of nursing and dental
- 20 hygiene to collect delinquent reimbursements of loan repayments
- 21 pursuant to this section may collect a commission from the

- 1 debtor in accordance with the terms of, and up to the amounts
- 2 authorized in, the written contract.
- 3 § -4 Hawaii health corps first responder service
- 4 obligation. In the event of a civil defense or other emergency,
- 5 proclaimed under chapter 127 or 128, physicians, physician
- 6 assistants, and nurse practitioners participating in the Hawaii
- 7 health corps program may be ordered into service by the governor
- 8 as first responders to serve in areas of the State and in a
- 9 capacity determined by the director of health.
- 10 § -5 Rules. The University of Hawaii John A. Burns
- 11 school of medicine and the University of Hawaii at Manoa school
- 12 of nursing and dental hygiene shall adopt rules to administer
- 13 this chapter. The rules shall be adopted pursuant to chapter
- 14 91, but shall be exempt from public notice and public hearing
- 15 requirements.

- 17 established in the treasury of the State the Hawaii health corps
- 18 revolving fund, which shall be administered by the University of
- 19 Hawaii John A. Burns school of medicine and the University of

- 21 which shall be deposited:

20	corps pro	gram no later than June 30, 2012.

- 19 year 2012-2013 to implement and sustain the Hilo medical
- 20 center's rural interdisciplinary residency program.
- 21 The sums appropriated shall be expended by the University
- 22 of Hawaii John A. Burns school of medicine and the University of

- 3 SECTION 6. There is appropriated out of the general

Description:

Establishes the Hawaii health corps program to provide loan repayments on behalf of eligible physicians, physician assistants, and nurse practitioners in any county having a shortage of physicians, physician assistants, and nurse practitioners, with priority given to those serving in rural areas. Provides for loan repayments by the University of Hawaii John A. Burns school of medicine and the University of Hawaii at Manoa school of nursing and dental hygiene. Creates the Hawaii health corps revolving fund. Makes appropriations to support accreditation efforts and support and expand residency programs, particularly in family medicine. Effective 7/1/2050. (SD1)
