A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- ${f 1}$ SECTION 1. There is established in the department of
- 2 education an electronic-based curriculum tools pilot program for
- 3 students in one public intermediate or middle school to be
- 4 selected by the department. The department shall provide, free
- 5 of charge for the 2011-2012 school year, electronic-based
- 6 curriculum tools presented in digital format to be read directly
- 7 from the screen of a personal computer, laptop, or other
- 8 portable device.
- 9 SECTION 2. The department of education shall select one
- 10 public intermediate or middle school and may select a subset of
- 11 students within that school to participate in the pilot program.
- 12 Selected students shall notify the department in writing of
- 13 their commitment to participate in the pilot program for the
- 14 school year or their election to not participate in the program.
- 15 Participating students shall use designated electronic-based
- 16 curriculum tools, downloadable to personal computers, laptops,
- 17 or other portable devices, for the duration of the school year,

- 1 with officials of the selected schools, shall determine other
- 2 rules and selection criteria for students and the electronic-
- 3 based curriculum tools to be used as part of the pilot program.
- 4 SECTION 3. During the school year, if a student or a
- 5 student's parents or guardians find that the student's
- 6 participation in the pilot program is detrimental to the
- 7 student's learning and desire to end participation in the
- 8 program, the student or the student's parents or guardians may
- 9 end the student's participation without penalty. Any student
- 10 who drops out of the program shall return any distributed
- 11 materials or publically-owned electronic devices to the
- 12 department of education in good working condition and shall not
- 13 be allowed to participate in the program for the remainder of
- 14 the school year.
- 15 SECTION 4. The department of education shall submit a
- 16 written report on the implementation and effectiveness of the
- 17 electronic-based curriculum tools pilot program to the
- 18 legislature no later than twenty days prior to the convening of
- 19 the 2013 regular session. The report shall include findings on
- 20 the costs and experience gained from the pilot program, and
- 21 recommendations for implementing an electronic-based curriculum

- 1 tools system for all public schools that address anticipated
- 2 problems and provide an estimate of the costs involved.
- 3 SECTION 5. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so
- 5 much thereof as may be necessary for fiscal year 2011-2012 for
- 6 the planning and implementation of an electronic-based
- 7 curriculum tools pilot program.
- 8 The sum appropriated shall be expended by the department of
- 9 education for the purposes of this Act.
- 10 SECTION 6. This Act shall take effect on July 1, 2011.
