### A BILL FOR AN ACT

RELATING TO WHISTLEBLOWERS' PROTECTION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that public employees may SECTION 1. 2 possess information about improper activities such as waste, fraud, and misconduct occurring in state and local government, 3 but may not report the information because of fear of 4 5 retaliation by their supervisors. Greater protection for public employees is necessary to encourage them to come forward with 6 information that will help ensure the efficiency and integrity 7 of state and local government. 8 9 The purpose of this Act is to provide additional protection 10 to public employees who report violations of the law and other 11 improper activities. SECTION 2. Chapter 78, Hawaii Revised Statutes, is amended 12

5		provided that the disclosure is made for the purpose

8	section 3	78-63, a public employee who alleges a violation of
9	this sect	ion may bring a civil action for punitive damages.
10	<u>(c)</u>	Every public employer shall post and keep posted
