A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. According to The Pew Center on the States, one in thirty-two adults in Hawaii is under correctional control. 2 The legislature recognized that the financial, social, and 3 economic costs of incarceration without adequate rehabilitation 4 are staggering, and thus enacted Act 8, Special Session Laws of 5 Hawaii 2007 (Act 8), also known as the Community Safety Act of 6 2007 and codified as chapter 353H, Hawaii Revised Statutes. 7 Act 8 8 established a comprehensive offender reentry system under the 9 purview of the department of public safety. One key component 10 of Act 8 requires the department of public safety to submit annual reports through 2010 relating to the implementation, 11 12 progress, and effectiveness of the various program components 13 specified in Act 8.

14 While the department's annual report lists program
15 activities and statistics, it does not include information on
16 program outcomes. The legislature finds that use of performance
17 indicators is an effective way to monitor and evaluate the
18 progress of the comprehensive reentry system and to reflect the

1	philosophical change to the department's approach to		
2	rehabilitation and reentry mandated by Act 8. Additionally, the		
3	legislature requires specific data to accurately assess programs		
4	and to continue to improve public policy.		
5	The purpose of this Act is to:		
6	(1) Direct the department of public safety to establish		
7	key performance indicators or measures to be

13	SECTION 2. Chapter 353H, Hawaii Revised Statutes, is		
14	amended by adding two new sections to be appropriately		
15	designated and to read as follows:		
16	"§353H- Performance indicator reporting. (a) The		
17	department of public safety shall develop performance measures		
18	that accurately reflect progress toward specific goals,		
19	including:		
20	(1) Improving recidivism rates;		
21	(2) Decreasing prisoner assaults on correctional staff;		
22	(3) Reducing correctional staff turnover; and

1	(4)	Improving departmental efficiencies in staffing,
2		budgeting, and data management and analysis.
3	(b)	The department shall develop key performance
4	indicator	s, which shall include:
5	(1)	The number of individuals enrolled in and who have
6	•	completed a general education diploma or competency-
7		based diploma;
8	(2)	The number of individuals for whom a reentry plan is
9		filed and the number of individuals who exit jail or
10		prison with a reentry plan;
11	(3)	Drug test failure rates of inmates while incarcerated
12		and while on parole;
13	(4)	The number of inmates currently enrolled in and who
14		have completed drug treatment programs provided by the
15	•	department of public safety;
16	(5)	The number of inmates currently enrolled in and who
17		have completed restorative circles;
18	(6)	The number of parolees who have applied for a
19		reduction of their minimum sentence, the number of
20		applications approved and denied, and, when
21		applicable, the reasons for the denial of a parolee's

5	The department of public safety shall also post the reports
6	electronically on the department's internet website in a timely
7	manner.
8	§353H- Quarterly reporting requirements. For each
9	program established pursuant to this chapter, the department
10	shall submit a report to the legislature within thirty days of
11	the last working day of the months of March, June, September,
12	and December, beginning with the period ending on September 30,
13	2011. Each report shall reference key performance indicators
14	that track rehabilitation and reentry efforts for individuals
15	being prepared to exit the correctional system. The report
16	shall also include:
17	(1) A complete list of programs offered;
18	(2) The length of each program;
19	(3) Each program's success rate, including the percentage
20	of participant completion in the previous two years;
21	(4) A description of participant criteria assessed by the
22	program for admittance;

1	(5) Number of available positions with each program;
2	(6) Number of potential participants on waiting lists;
3	(7) Number of participants who do not complete the

9	SECTION 3. Section 353G-13, Hawaii Revised Statutes, is
10	amended by amending subsection (c) to read as follows:
11	"(c) The department of public safety, in conjunction with
12	the department of health, shall report on $[an annual]$ a
13	quarterly basis to the legislature and to the governor, its
14	findings concerning the need for and implementation of the
15	various provisions of this chapter. The report shall include
16	information collected under subsection (a) and a synopsis of
17	information or data necessary to determine the impact, utility,
18	and cost-benefits of the provisions of this chapter. The report
19	shall also include:
20	(1) A complete list of programs offered;
21	(2) The length of each program;
