# A BILL FOR AN ACT

RELATING TO HEALTH.

# BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that both physician 2 assistants and registered nurses provide valuable medical care to patients under the orders of licensed physicians. 3 The legislature acknowledges that registered nurses are licensed 4 under chapter 457, Hawaii Revised Statutes, and are regulated by 5 the board of nursing, whereas physician assistants are licensed 6 under section 453-5.3, Hawaii Revised Statutes, and practice 7 under the supervision of a physician or osteopathic physician. 8 When performing the practice of nursing as a registered nurse, a 9 registered nurse must currently use reasonable judgment in 10 11 carrying out prescribed medical orders of a licensed dentist, medical doctor, osteopathic physician, or podiatrist, or the 12 orders of an advanced practice registered nurse. 13

14 Since the historical process of licensing and regulating 15 the scopes of practice of physician assistants and of registered 16 nurses has developed independently for the two health care 17 disciplines, the legislature finds that the relevant statutory 18 language pertaining to their respective responsibilities is 2011-1407 SB705 SD1 SMA-1.doc

1 unclear. Specifically, there is a lack of clarity with respect 2 to nurses administering orders given by physician assistants and 3 this has led to confusion between hospital administrators and 4 nurses when physician assistants write or give verbal orders in 5 a hospital setting.

6 SECTION 2. Section 457-2, Hawaii Revised Statutes, is
7 amended by amending the definition of "the practice of nursing
8 as a registered nurse" to read as follows:

9 "The practice of nursing as a registered nurse" means the 10 performance of professional services commensurate with the 11 educational preparation and demonstrated competency of the 12 individual having specialized knowledge, judgment, and skill 13 based on the principles of the biological, physical, behavioral, 14 and sociological sciences and nursing theory, whereby the individual shall be accountable and responsible to the consumer 15 for the quality of nursing care rendered. The foregoing may 16 17 include but shall not be limited to observation, assessment, development, implementation, and evaluation of a plan of care, 18 health counseling, supervision and teaching of other personnel, 19 20 and teaching of individuals, families, and groups in any stage 21 of health or illness; administration, supervision, coordination, 22 delegation, and evaluation of nursing practice; provision of 2011-1407 SB705 SD1 SMA-1.doc

1	health care to the patient in collaboration with other members
2	of the health care team as autonomous health care professionals
3	providing the nursing component of health care; or use of
4	reasonable judgment in carrying out prescribed medical orders of
5	a licensed dentist, physician, osteopathic physician, or
6	podiatrist licensed in accordance with chapter 448, 453, or 463E
7	or the orders of an advanced practice registered nurse
8	recognized in accordance with this $chapter[-]$ or a physician
9	assistant licensed in accordance with chapter 453 and practicing
10	with physician supervision as required by chapter 453."
11	SECTION 3. Statutory material to be repealed is bracketed
12	and stricken. New statutory material is underscored.
13	SECTION 4. This Act shall take effect upon its approval.
