BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The purpose of this Act is to amend the uses of
 the Hawaii community-based economic development revolving fund
 to include operational funding and a funding mechanism for the
 enterprise zone program.

5 SECTION 2. Section 210D-4, Hawaii Revised Statutes, is
6 amended to read as follows:

7 "§210D-4 Hawaii community-based economic development revolving fund; established. (a) There is established a 8 9 revolving fund to be known as the Hawaii community-based economic development revolving fund [from which moneys shall be 10 11 loaned or granted by the department under this chapter]. All 12 moneys appropriated to the fund by the legislature, received as 13 repayments of loans, payments of interest or fees, and all other 14 moneys received by the fund from any other source shall be deposited into the revolving fund and used for the purposes of 15 16 this chapter.
