A BILL FOR AN ACT

RELATING TO ECONOMIC DEVELOPMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The purpose of this Act is to amend the uses of
the Hawaii community-based economic development revolving fund
to include operational funding and a funding mechanism for the
enterprise zone program.

5 SECTION 2. Section 210D-4, Hawaii Revised Statutes, is 6 amended to read as follows:

"§210D-4 Hawaii community-based economic development 7 revolving fund; established. (a) There is established a 8 9 revolving fund to be known as the Hawaii community-based economic development revolving fund [from which moneys shall be 10 loaned or granted by the department under this chapter]. All 11 moneys appropriated to the fund by the legislature, received as 12 repayments of loans, payments of interest or fees, and all other 13 moneys received by the fund from any other source shall be 14 deposited into the revolving fund and used for the purposes of 15 16 this chapter.

2	other moneys in the revolving fund not appropriated for a

4	(1)	Fund the operations of the community-based economic

17	SECTION 3. There is appropriated out of the general

21	year 2012-2013 for deposit in the Hawaii community-based

Revised Statutes.

3 SECTION 4. There is appropriated out of the Hawaii 4 community-based economic development revolving fund the sum of 5 Ś or so much thereof as may be necessary for fiscal 6 year 2011-2012 and the same sum or so much thereof as may be 7 necessary for fiscal year 2012-2013 for the operations of the community-based economic development program established under 8 chapter 210D, Hawaii Revised Statutes, and the enterprise zone 9 program established under chapter 209E, Hawaii Revised Statutes. 10 The sums appropriated shall be expended by the department 11 12 of business, economic development, and tourism for the purposes 13 of this Act. SECTION 5. Statutory material to be repealed is bracketed 14

14 SECTION 5. Statutory material to be repeated is bracketed 15 and stricken. New statutory material is underscored.

16 SECTION 6. This Act shall take effect on July 1, 2011.
