1 Section 87A-1, Hawaii Revised Statutes, is SECTION 1. 2 amended by amending the definitions of "health benefits plan" 3 and "long-term care benefits plan" to read as follows: ""Health benefits plan" means [+ 4 5 A] a group insurance contract or service agreement (1)6 that may include medical, hospital, surgical, 7 prescribed drugs, vision, and dental services, in 8 which a carrier agrees to provide, pay for, arrange 9 for, or reimburse the cost of the services as 10 determined by the board [; or 11 (2) A similar schedule of benefits established by the 12 board and provided through the fund on a self-insured 13 basis]."

14 "Long-term care benefits plan" means [+

15 (1) A] <u>a</u> group insurance contract or service agreement in
16 which a carrier agrees to provide, pay for, arrange
17 for, or reimburse the cost of long-term care benefits
18 as determined by the board[; or

4	SECTION 2. Section 87A-16, Hawaii Revised Statutes, is
5	amended to read as follows:

7	The board shall establish the health benefits plan or plans,
8	which shall be exempt from the minimum group requirements of
9	chapter 431.
10	[(b) The board may contract for health benefits plans or
