BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to provide 2 procurement authority to semi-autonomous county public transit 3 agencies, including the agency known as the Honolulu authority 4 for rapid transportation, to allow them to function as semi-5 autonomous agencies of their respective counties. 6 SECTION 2. Section 103D-203, Hawaii Revised Statutes, is 7 amended by amending subsections (b) and (c) to read as follows: 8 "(b) The chief procurement officers for each of the 9 several counties shall be: 10 (1) The executive branch--the respective finance directors 11 of the several counties, except as provided in 12 paragraphs (3) [and], (4) [+], and (5); 13 The legislative branch--the respective chairpersons of (2)14 the councils of the several counties; The Honolulu, Kauai, and Maui boards or departments of 15 (3) 16 water supply--the managers and chief engineers of the 17 respective boards or departments of water supply as 18 designated by county charter; [and]
