A BILL FOR AN ACT

RELATING TO A MEMORIAL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The freedom and security that citizens of the SECTION 1. 2 United States enjoy today are direct results of the sacrifices and continued vigilance of the United States armed forces over 3 the course of our nation's history. The sacrifices of the 4 5 members of the United States armed forces have preserved the 6 liberties of this nation that have made it unique in the world 7 community. Members of the United States armed forces engaged in 8 the Persian Gulf War from August 2, 1990, to February 27, 1991, 9 that culminated in the liberation of Kuwait from Iraq. The 10 United States air-and-land conflict, known as Operation Desert 11 Storm, began on January 17, 1991, and lasted through April 11, 12 1991. Operation Iraqi Freedom was a military campaign led by 13 United States troops that began on March 20, 2003, and lasted through August 31, 2010. It was later named Operation New Dawn 14 15 on September 1, 2010. Also known as the "War in Afghanistan", Operation Enduring Freedom is an ongoing war effort that began 16 17 on October 7, 2001. On July 24, 1994, Hawaii dedicated the 18 Korean and Vietnam War Memorial on the grounds of the state 2011-1109 SB882 SD1 SMA.doc

capitol. Thus, it is both fitting and necessary for the State
to give tangible and visible recognition of the sacrifices and
contributions of veterans from Hawaii who served in the Persian
Gulf War, Operation Desert Storm, Operation Iraqi Freedom,
Operation Enduring Freedom, Operation New Dawn, Operation
Northern Watch, Operation Southern Watch, and other Middle East
combat conflicts beginning with Operation Desert Storm.

SECTION 2. The office of veterans' services, with the 8 9 assistance of the department of accounting and general services 10 and the department of defense, shall develop a plan to establish 11 a memorial honoring the veterans of the Persian Gulf War, Operation Desert Storm, Operation Iraqi Freedom, Operation 12 13 Enduring Freedom, Operation New Dawn, Operation Northern Watch, Operation Southern Watch, and other Middle East combat conflicts 14 15 beginning with Operation Desert Storm, on the grounds of the 16 state capitol near the Korean and Vietnam War memorial or on any 17 other location on Oahu near the state capitol.

18 The plan shall include proposals to fund the memorial19 through a public-private partnership.

20 A public hearing shall be held to receive comments or input21 from interested organizations and residents.
