A BILL FOR AN ACT

RELATING TO SPECIAL NUMBER PLATES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 Section 249-9.2, Hawaii Revised Statutes, is SECTION 1. 2 amended by amending subsections (a) and (b) to read as follows: 3 "(a) In lieu of the number plates contracted on behalf of 4 the counties by the director of finance of the city and county of Honolulu, the director of finance shall provide for a fee, 5 one set of special number plates upon the receipt of an 6 7 application together with: 8 Specific proof that the applicant was awarded the 9 Purple Heart by the United States Department of 10 Defense for wounds received in military or naval 11 combat against an armed enemy of the United States; 12 Certification that the applicant is a veteran; (2) 13 (3) Specific proof that the applicant was serving the United States in the military or as a civilian, on 14 15 Oahu, or offshore at a distance of not more than three 16 miles at the time of the December 7, 1941, attack on

Pearl Harbor. Certification from the Hawaii state
