### A BILL FOR AN ACT

RELATING TO THE HAWAII NATIONAL GUARD.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Last year, President Barack Obama selected 2 Honolulu as the site for the annual Asia Pacific Economic 3 Cooperation Leaders Meeting in November 2011. The Asia Pacific 4 Economic Cooperation is the premier forum for cooperation 5 between Asia-Pacific economies on trade and investment issues. 6 The annual Asia Pacific Economic Cooperation gathering is 7 one of the world's largest intergovernmental meetings and is 8 attended by heads of state, cabinet ministers, the heads of the 9 World Bank and World Trade Organization, and other business 10 leaders. This will be the largest such gathering in Hawaii's

Scheduled for November 12-20, 2011, the meetings will be very beneficial for Hawaii's economy, as they are expected to draw more than ten thousand people to Honolulu and will provide a boost to the State's struggling tourism industry.

12	specifically provided in section 134-16(c) and (d), when		
13	assisting civil authorities in disaster relief, civil defense,		
14	or law enforcement functions."		
15	SECTION 3. Section 134-16, Hawaii Revised Statutes, is		
16	amended by amending subsections (c) and (d) to read as follows:		
17	"(c) This section shall not apply to [ <del>law</del> ]:		
18	(1) Law enforcement officers of county police		
19	departments[ <del>, law</del> ] <u>;</u>		
20	(2) Law enforcement officers of the department of public		
21	safety[ <del>, and conservation</del> ];
